

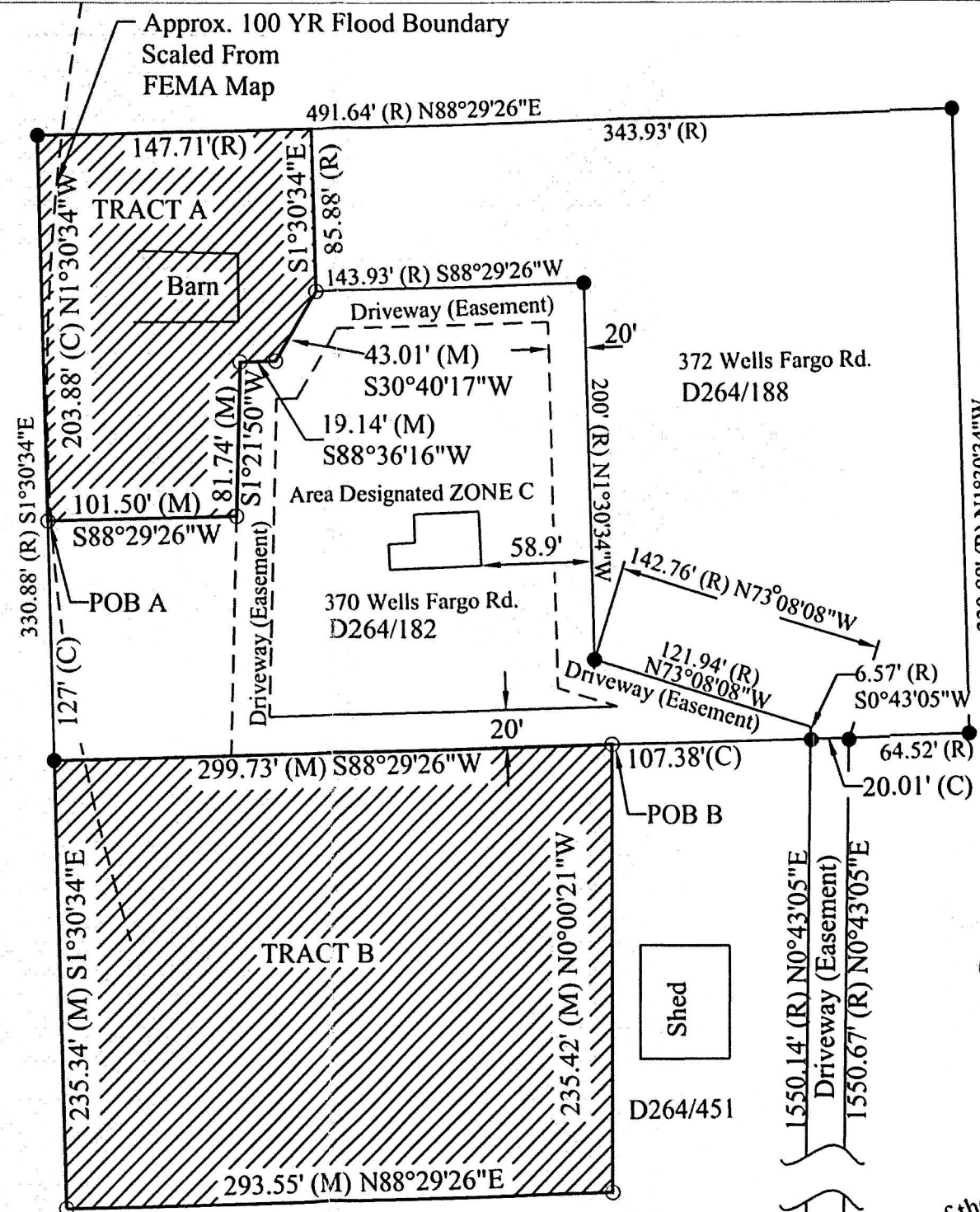
TRACT A (Tract taken from 370 Wells Fargo and added to 372 Wells Fargo):

Commencing at the SE corner of the SE 1/4 Section 10 Township 17 South Range 5 West of the 6th P.M.; thence along the south line of said SE1/4 Section 10 on an assumed bearing of N90° 00' 00" W, 1531.64'; thence N0° 43' 05" E, 1583.14'; thence S88° 29' 26" W, 407.11'; thence N1°30'34"W, 127.00' to the point of beginning; thence N1°30'34"W, 203.88'; thence N88°29'26"E, 147.71'; thence S01°30'34" E, 85.88'; thence S30°40'17"W, 43.01'; thence S88°36'16"W, 19.14'; thence S1°21'50"W, 81.74'; thence S88°29'26"W 101.50' to the point of beginning containing 0.60 acres more or less in McPherson County, Kansas and a 20' driveway easement for access to tracts A and B as shown on this plat of survey.

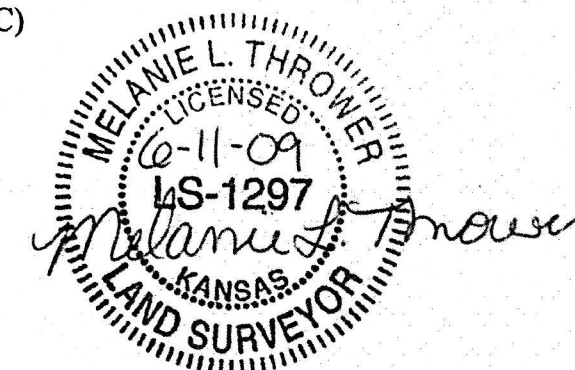
● Existing 1/2" x 2' Rebar Set 12/17/2003
