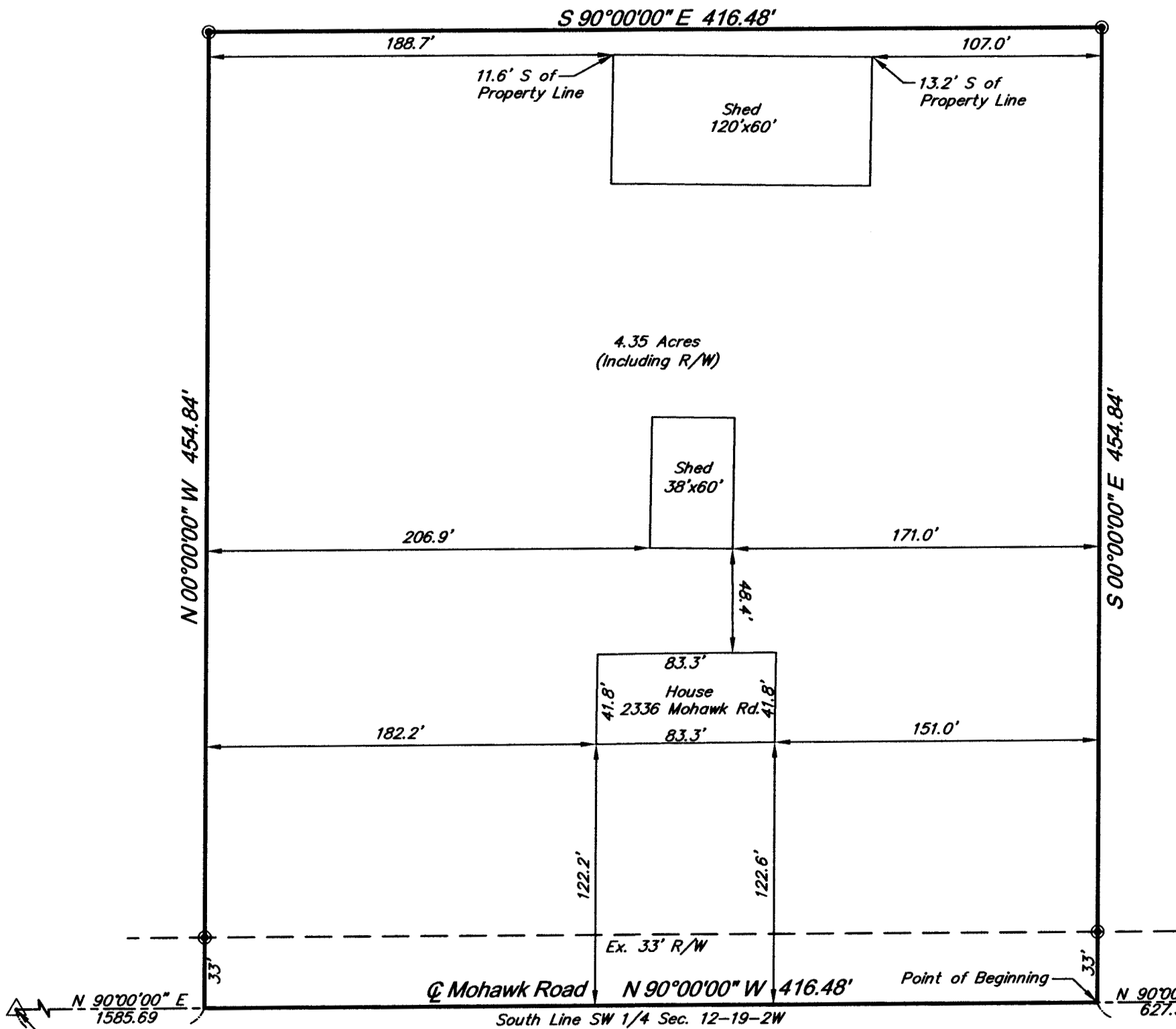

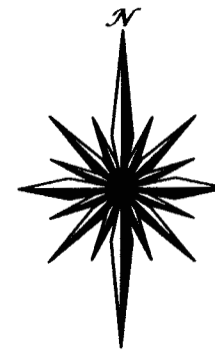

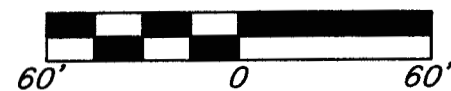

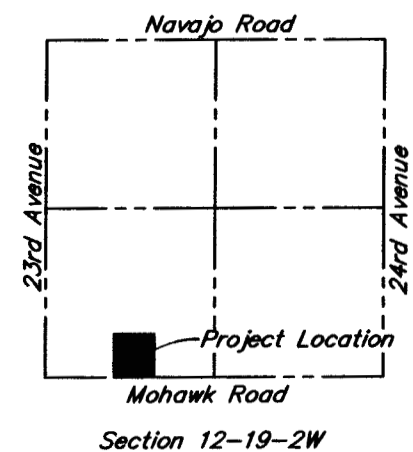


### Legend

***Legal Description (Recommended):***

*A portion of Southwest Quarter of Section 12, Township 19 South, Range 2 West of the 6th Principle Meridian, McPherson County, Kansas, being more particularly described as follows:*

Commencing at the Southeast corner of said Southwest Quarter; thence North 90°00'00" West, along the South line of said Southwest Quarter, a distance of 627.38 feet to the POINT OF BEGINNING; thence continuing North 90°00'00" West, along said South line, a distance of 416.48 feet; thence North 00°00'00" West, perpendicular to the South line of said Southwest Quarter, a distance of 454.84 feet; thence South 90°00'00" East, parallel to the South line of said Southwest Quarter, a distance of 416.48 feet; thence South 00°00'00" East, perpendicular to the South line of said Southwest Quarter, a distance of 454.84 feet to the POINT OF BEGINNING and containing 4.35 acres, more or less and subject to any rights of way, restrictions, or easements of record or fact.
