DESCRIPTION

A tract of land in the South Half of the Northwest Quarter of Section 13, Township 21 South, Range 3 West of the 6th Principal Meridian described as follows:

Beginning at the Southeast corner of the South Half of the Northwest Quarter of Section 13, Township 21 South, Range 3 West of the 6th Principal Meridian; thence West along the South line of said Northwest Quarter 418.00 feet; thence with a deflection angle 89°55'12" right—North parallel with the East line of said Northwest Quarter 666.44 feet; thence with a deflection 90°33'04" right—East 418.02 feet to the East line of said Northwest Quarter; thence with a deflection angle 89°26'56" right—South along the East line of said Northwest Quarter 663.00 feet to the point of beginning containing 6 379 Acres in McPherson County Kappas TOCETHER WITH an 6.379 Acres in McPherson County, Kansas TOGETHER WITH an Ingress—Egress Easement more particularly described as follows:

Commencing at the Southeast corner of the South Half of


