

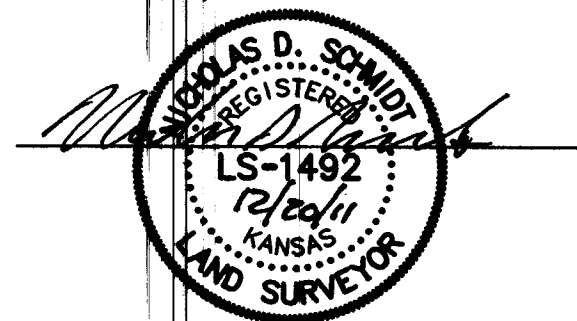

Commencing at the Southeast corner of the Southeast Quarter of Section 15, Township 19 South, Range 1 West of the 6th Principal Meridian; thence on a Kansas State Plane South Zone bearing of South 88°49'07" West along the South line of said Southeast Quarter 1776.00 feet (1776.00 Record) to the Southwest corner of a parcel described in Book 173, Page 319 in McPherson County, Kansas, said corner also being the point of beginning; thence continuing South 88°49'07" West along said South line 25.00 feet; thence North 01°10'53" West parallel with the West line of said parcel described in Book 173, Page 319 a distance of 942.00 feet; thence North 88°49'07" East parallel with said the South line of said Southeast Quarter 25.00 feet to the Northwest corner of a parcel described in Book 173, Page 317 in McPherson County, Kansas; thence South 01°10'53" East along the West lines of said parcels described in Book 173, Page 317 and Book 173, Page 319 a distance of 942.00 feet (942.00 Record) to the point of beginning, containing **0.541 Acre** and subject to a road right of way easement across the South 35.00 feet thereof and any other easements of record.

Commencing at the Southeast corner of the Southeast Quarter of Section 15, Township 19 South, Range 1 West of the 6th Principal Meridian; thence on a Kansas State Plane South Zone bearing of South 88°49'07" West along the South line of said Southeast Quarter 1716.00 feet (1716.00 Record) to the Southeast corner of a parcel described in Book 173, Page 319 in McPherson County, Kansas, said corner also being the point of beginning; thence continuing South 88°49'07" West along said South line 25.00 feet; thence North 01°10'53" West parallel with the East line of said parcel described in Book 173, Page 319 a distance of 942.00 feet to the North line of a parcel described in Book 99, Page 583 in McPherson County, Kansas; thence North 88°49'07" East along said North line 25.00 feet to the Northwest corner of a parcel described in Book 646, Page 6878 in McPherson County, Kansas; thence South 01°10'53" East along the West line of said parcel described in Book 646, Page 6878 and the East line of said parcel described in Book 173, Page 319 a distance of 942.00 feet (942.00 Record) to the point of beginning, containing 0.541 Acres and subject to a road right of way easement across the South 33.00 feet thereof and any other easements of record.
