



DESCRIPTION: PARCEL 1

BASIS OF BEARING = ASSUMED

A portion of the Southwest Quarter of Section 16, Township 20 South, Range 1 West of the 6th Principal Meridian, McPherson County, Kansas more particularly described as follows:

Beginning at the Southwest Corner of the Southwest Quarter of Section 16, Township 20 South, Range 1 West of the 6th Principal Meridian; thence with an assumed bearing of North 01°07'00" West along the West line of said Southwest Quarter 768.27 feet; thence departing said line bearing North 90°00'00" East parallel with the South line of said Southwest Quarter 2654.73 feet to the East line of said Southwest Quarter; thence South 00°58'38" East along the East line of said Southwest Quarter 261.26 feet to a point that is 506.98 feet North of the Southeast Corner of said Southwest Quarter; thence departing said line bearing North 00°00'00" West parallel with the South line of said Southwest Quarter 616.97 feet; thence South 01°07'00" East parallel with the West line of said Southwest Quarter 263.26 feet; thence North 90°00'00" East parallel with the South line of said Southwest Quarter 67.29 feet; thence South 01°07'00" East parallel with the West line of said Southwest Quarter 243.74 feet to the South line of said Southwest Quarter; thence North 90°00'00" West along the South line of said Southwest Quarter 2104.43 feet to the point of beginning containing 40.00 Acres, subject to road right—of—way easements across the South and West 33.00 feet thereof and any other easements of record.


PARCEL 2

Beginning at the Southeast Corner of the Southwest Quarter of Section 16, Township 20 South, Range 1 West of the 6th Principal Meridian; thence with an assumed bearing of thence North 90°00'00" West along the South line of said Southwest Quarter 548.45 feet; thence departing said line bearing North 01°07'00" West parallel with the West line of said Southwest Quarter 243.74 feet; thence North 90°00'00" West parallel with the South line of said Southwest Quarter 67.29 feet; thence North 01°07'00" West parallel with the West line of said Southwest Quarter 263.26 feet; thence North 90°00'00" East parallel with the South line of said Southwest Quarter 616.97 feet to the East line of said Southwest Quarter; thence South 00'58'38" East along the East line of said Southwest Quarter 506.98 feet to the point of beginning containing 6.796 Acres, subject to a road right-of-way easement across the South 33.00 feet thereof and any other easements of record.
