DESCRIPTION OF RECORD: A part of the West Half of the Southwest Quarter (W ½ SW ¼) of Section Seventeen (17) Township Seventeen (17) South, Range Three (3) West of the Sixth Principal Meridian, Described as follows;
Commencing at a point 580 feet West and 150 feet South of the Northeast corner of said W ½ SW ¼ of Section 17, thence South 89 feet, thence West 80 feet, thence East 80 feet to place of beginning, McPherson County, Kansas.

SURVEY DESCRIPTION: A portion of the West Half of the Southwest Quarter of Section 17, Township 17 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Northeast corner of the West Half of the Southwest Quarter of Section 17, Township 17 South, Range 3 West of the 6th Principal Meridian; thence on a Kansas State Plane Zone 1502 Bearing of South 89°11'04" West 580.00 feet (Record); thence South 01°11'32" East 149.89 feet (150.0 Record) to the point of beginning; thence South 00°15'49" East 88.74 feet (89.0 Record) to the North Right of Way of Grant Street; thence South 89°31'43" West along said Right of Way 80.00 feet (Record); thence North 00°45'13" West 89.88 feet (89.00 Record); thence South 89°39'52" East 80.77 feet to the point of beginning, containing 7,179.04 Square Feet, subject to any easements or restrictions of record.

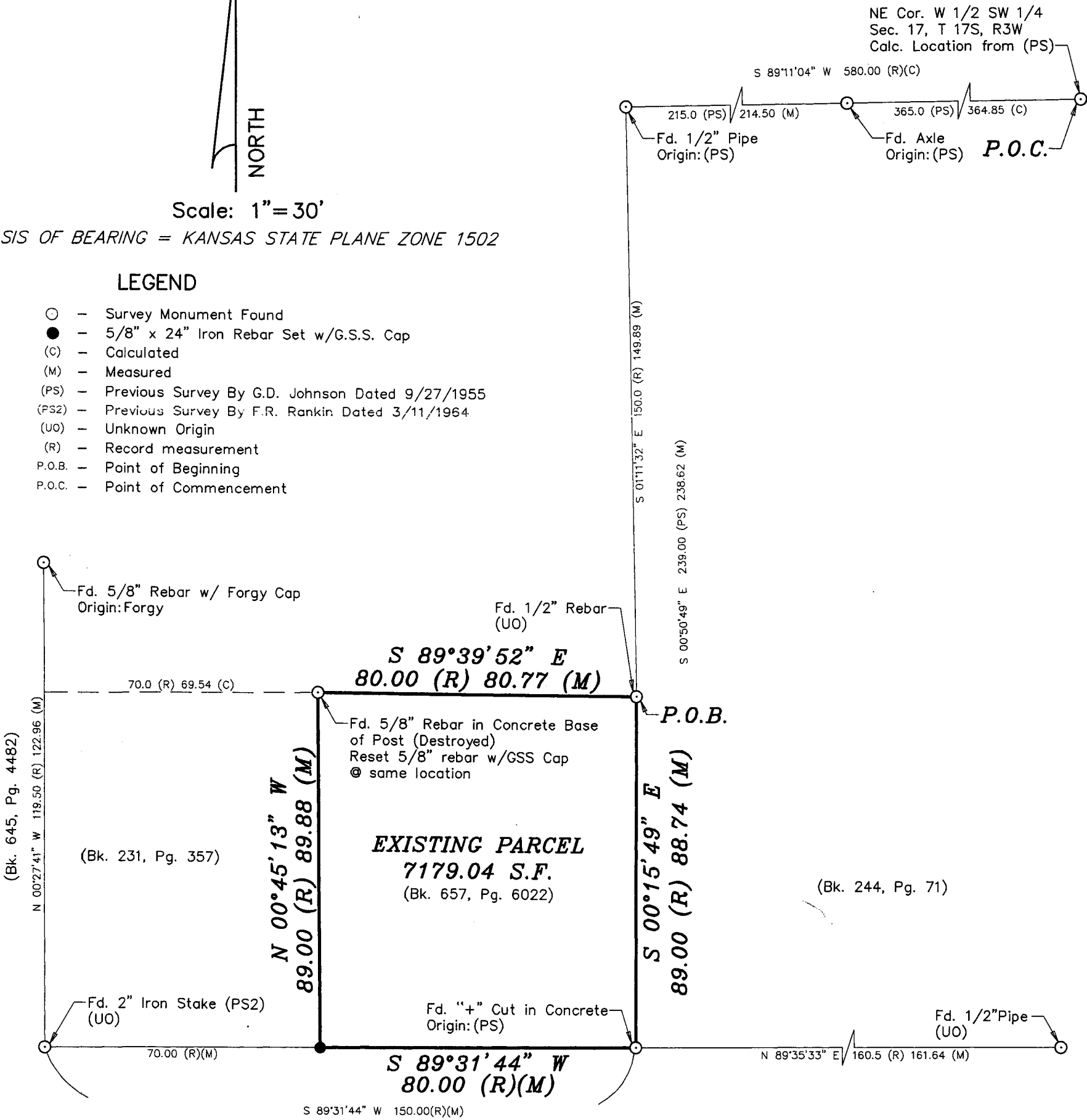
