PART OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE/4 SE/4) OF SECTION SEVENTEEN (17), TOWNSHIP SEVENTEEN (17) SOUTH, RANGE THREE (3) WEST OF THE 6TH P.M., DESCRIBED AS FOLLOWS: BEGINNING AT A POINT 80 FEET SOUTH OF THE SOUTHWEST CORNER OF LOT FORTY-NINE (49) MAPLE STREET EAST ADDITION TO LINDSBORG, WHICH POINT WAS FORMERLY THE NORTHWEST CORNER OF LOT FIFTY-ONE (51) ON MAPLE STREET, IN SAID ADDITION, THENCE SOUTH 423 FEET TO THE NORTH LINE OF MCPHERSON STREET IN SAID CITY, THENCE EAST 475 FEET TO POINT OF BEGINNING, THENCE EAST 200 FEET, THENCE NORTH 433.27 FEET TO THE SOUTH LINE OF UNION STREET OF SAID CITY, THENCE WEST 200 FEET TO PLACE OF BEGINNING.

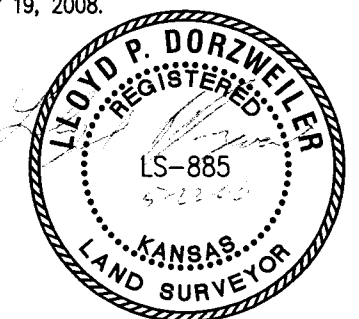

ACCORDING TO A SURVEY BY WILLIAM HELLER NORTH OF UNION STREET HIS MEASURED VERSUS PLATTED CHECKED WELL. I DECIDED TO PRORATE THE EAST PROPERTY LINE AGAINST THE MONUMENTS FOUND ON THE WEST SIDE OF THE PROPERTY.

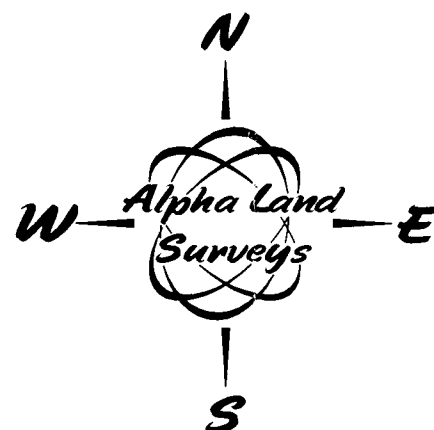


SE CORNER NE 1/4 SE 1/4
