

## DESCRIPTION:

## PARCEL 1

A portion of the North Half of the Northeast Quarter of Section 19, Township 17 South, Range 5 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Northeast corner of said Northeast Quarter; thence on a NAD 83 Kansas South Zone bearing of South 00°33'33" East on the East line of said Northeast Quarter a distance of 404.94 feet to the point of beginning; thence continuing South 00°33'33" East on said East line a distance of 912.34 feet to the Southeast corner of the North Half of said Northeast Quarter; thence North 89°43'27" West on the South line of said North Half a distance of 2644.20 feet to the Southwest corner of said North Half; thence North 00°45'41" West on the West line of said North Half a distance of 1319.12 feet to the Northwest corner of said Northeast Quarter; thence South 89°41'10" East on the North-line of said Northeast Quarter andistance of 2243.94 feet to a point 404.94 feet West of the Northeast corner of said Northeast Quarter; thence South 00°33'33" East parallel with the East line of said Northeast Quarter a distance of 404.94 feet; thence South 89°41'10" East parallel with the North line of said Northeast Quarter a distance of 404.94 feet to the point

Containing **76.314 Acres** and subject to Highway K 4 Right of Way along the North line thereof and a road right of way easement across the East 33.00 feet thereof, and any other easements or restrictions of record.

# PARCEL 2

A portion of the North Half of the Northeast Quarter of Section 19, Township 17 South, Range 5 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Northeast corner of said Northeast Quarter; thence on a NAD 83 Kansas South Zone bearing of South 00°33'33" East on the East line of said Northeast Quarter a distance of 208.71 feet (Record) to the point of beginning; thence continuing South 00°33'33" East on said East line a distance of 196.23 feet; thence North 89°41'10" West parallel with the North line of said Northeast Quarter a distance of 404.94 feet; thence North 00°33'33" West parallel with said East line a distance of 404.94 feet to said North line; thence South 89°41'10" East on said North line a distance of 196.23 feet to a point 208.71 feet (Record) West of the Northeast corner of said Northeast Quarter; thence South 00°33'33" East parallel with said East line a distance of 208.71 feet (Record); thence South 89'41'10" East parallel with said North line a distance of 208.71 feet (Record) to the point of beginning.

Containing 2.764 Acres and subject to Highway K 4 Right of Way along the North line thereof and a road right of way easement across the East 33.00 feet thereof, and any other easements or restrictions of record.


# SURVEYOR'S NOTES:

1. Found 2 sandstone fragments partially buried at ancient fence corner. Accepted as the corner monument and set 5/8" rebar with GSS cap in center of

2.Located the ancient East/West fence line along the South line of the North Half and accepted its position with consideration of the found sandstone fragments at the Southwest corner. Intersected line of fence with East line of the Northeast Quarter to establish the position of the Southeast corner.
