DESCRIPTIONS

Portions of the Southeast Quarter of Section 20, Township 21 South, Range 2 West of the 6th Principal Meridian described as follows:

PARCEL 1

Commencing at the Southwest corner of the Southeast Quarter of Section 20, Township 21 South, Range 2 West of the 6th Principal Meridian; thence North along the West line of said Southeast Quarter 1399.17 feet to the point of beginning, said point being 77.55 feet North of the Southwest corner of the North Half of said Southeast Quarter; thence continuing North along the West line of said North Half of the Southeast Quarter 1244.05 feet to the Northwest corner of said North Half of the Southeast Quarter; thence with a deflection angle 89°52'38" right—East along the North line of said North Half of the Southeast Quarter 328.72 feet; thence with a deflection angle 90°17'44" right-South 1098.07 feet; thence with a deflection angle 50°07'47" right-Southwesterly 237.57 feet; thence with a deflection angle 41°43'43" right—West 142.70 feet to the point of beginning, containing 9.049 Acres in McPherson County, Kansas subject to any easements of record.

PARCEL 2

Beginning at the Southwest corner of the Southeast Quarter of Section 20, Township 21 South, Range 2 West of the 6th Principal Meridian; thence North along the West line of said Southeast Quarter 1399.17 feet to a point 77.55 feet North of the Southwest corner of the North Half of said Southeast Quarter; thence with a deflection angle 92°01'52" right—East 142.70 feet; thence with a deflection angle 41'43'43" left—Northeasterly 237.57 feet; thence with a deflection angle 50'07'47" left—North 1098.07 feet to the North line of said Southeast Quarter; thence with a deflection angle 89'42'16" right—East along the North line of said Southeast Quarter 330.20 feet; thence with a deflection angle 90°05'00" right—South 1321.40 feet to the South line of the North Half of said Southeast Quarter; thence with a deflection angle 16°49'38" left—Southeasterly 107.78 feet; thence with a deflection angle 107°02'29" right—West 479.87 feet; thence with a deflection angle 90°05'51" left—South 972.17 feet; thence with a deflection angle 73°39'59" left—Southeasterly 111.67 feet; thence with a deflection angle 73°25'50" right—South 216.95 feet to the South line of said Southeast Quarter; thence with a deflection angle 90°00'00" right—West along the South line of said Southeast Quarter 317.64 feet to the point of beginning, containing 19.001 Acres in McPherson County, Kansas subject to a road right—of—way easement across the South 50.00 feet thereof and any other easements of record. thereof and any other easements of record.

PARCEL 3

Commencing at the Southwest corner of the Southeast Quarter of Section 20, Township 21 South, Range 2 West of the 6th Principal Meridian; thence East along the South line of said South, Range 2 West of the 6th Principal Meridian; thence East along the South line of said Southeast Quarter 317.64 feet to the point of beginning; thence with a deflection angle 90°00'00 left—North 216.95 feet; thence with a deflection angle 73°25'50" left—Northwesterly 111.67 feet; thence with a deflection angle 73°39'59"right—North 972.17 feet; thence with a deflection angle 90°05'51" right—East 479.87 feet; thence with a deflection angle 107°02'29" left—Northerly 107.78 feet to a point on the North line of the South Half of said Southeast Quarter; thence with a deflection angle 106°43'33" right—East along the North line of the South Half of the Southeast Quarter 1979.46 feet to the Northeast corner of the South Half of said Southeast Quarter; thence with a deflection angle 89°58'57" right—South along the East line of said Southeast Quarter 1320.78 feet to the Southeast corner of said Southeast Quarter; thence with a deflection angle 89°59'59" right—West along the South line of said Southeast Quarter 2325.29 feet to the point of beginning, containing 72.060 Acres in McPherson County, Kansas subject to road right—of—way easements across the South 50.00 feet and the East 33.00 feet thereof and any other easements of record.
