DESCRIPTION OF TRACTS:

TRACT A IN THE SEV4 SECTION 21, T19S, R3W AND DESCRIBED AS FOLLOWS:

BEGINNING AT THE NE CORNER OF THE SEV4 SECTION 21, T19S, R3W, THENCE WEST 210' FEET, THENCE EAST 210' FEET TO THE SECTION LINE, THENCE NORTH ON THE SECTION LINE 156.15' FEET TO THE POINT OF BEGINNING. SAID TRACT CONTAINS 0.75 ACRES MORE OR LESS.

TRACT B IN THE SEV4 SECTION 21, T19S, R3W AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT 156.15' FEET SOUTH OF THE NE CORNER OF THE SEV4 SECTION 21, T19S, R3W, THENCE WEST 210' FEET, THENCE SOUTH 103' FEET, THENCE EAST 210' FEET TO THE SECTION LINE, THENCE NORTH 103' FEET TO THE POINT OF BEGINNING. SAID TRACT CONTAINS 0.50 ACRES MORE OR LESS.

TRACT C IN THE SEV4 SECTION 21, T19S, R3W AND DESCRIBED AS FOLLOWS:

Beginning at a point 259.15° feet south of the NE corner of the  $\mathbb{S}^{1/4}$  Section 21, T19S, R3W, thence west 210° feet, thence south 103° feet, thence east 210° feet to the section line, thence north 103° feet to the point of beginning. Said tract contains 0.50 acres more or less.

TRACT D IN THE SEV4 SECTION 21, T19S, R3W AND DESCRIBED AS FOLLOWS:

Beginning at a point 412.15° feet south of the NE corner of the SEV4 Section 21, T19S, R3W thence west 210° feet, thence south 206.85° feet, thence east 210° feet to the section line, thence north 206.85° feet to the point of beginning. Said tract contains 1.00 acres more or less.

TRACT E IN THE SEV4 SECTION 21, T195, R3W AND DESCRIBED AS FOLLOWS.

BEGINNING AT A POINT 619.0' FEET SOUTH OF THE NE CORNER OF THE SEV4 SECTION 21, T19S, R3W THENCE WEST 210' FEET, THENCE SOUTH 205.85' FEET MORE OR LESS, THENCE EAST 210' FEET TO THE SECTION LINE, THENCE NORTH 206.85' FEET MORE OR LESS TO THE POINT OF BEGINNING. SAID TRACT CONTAINS 1.00 ACRES MORE OR LESS.
