


GATE VALVE SETTING EASEMENT

TRACT IN SW.1/4, SECTION 23, T19S, R3W
McPHERSON COUNTY, KANSAS



LEGAL DESCRIPTION

That part of the Southwest Quarter of Section 23, Township 19 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas, described as follows:
Commencing at the southwest corner of said Section 23; thence on an assumed bearing of North 90 degrees 00 minutes 00 seconds East, along the south line of the Southwest Quarter of said section, a distance of 156.86 feet; thence on a bearing of North 00 degrees 00 minutes 00 seconds East a distance of 33.00 feet to a point on the north right-of-way line of a county road, said point being the point of beginning of the easement to be described; thence on a bearing of North 34 degrees 23 minutes 00 seconds East a distance of 336.23 feet; thence on a bearing of South 55 degrees 37 minutes 00 seconds East a distance of 126.02 feet; thence on a bearing of South 34 degrees 23 minutes 00 seconds West a distance of 250.00 feet to the north right-of-way line of said county road; thence on a bearing of South 90 degrees 00 minutes 00 seconds West, along the north right-of-way line of said county road, a distance of 152.70 feet to the point of beginning.
The above described tract of real estate contains 0.8480 acre.
