

BUCKSKIN ROAD



DESCRIPTION

A portion of the West Half of the Northeast Quarter of Section 24, Township 21 South, Range 4 West of the 6th Principal Meridian, McPherson County, Kansas described as follows: Commencing at the Northwest corner of the Northeast Quarter of Section 24, Township 21 South, Range 4 West of the 6th Principal Meridian; thence with an assumed bearing of South 90°00'00" East along the North line of said Northeast Quarter 493.91 feet to the Northeast corner of the West 30.00 Acres of said Northeast Quarter for the point of basining: 30.00 Acres of said Northeast Quarter for the point of beginning; thence continuing South 90°00'00" East along said section line 76.52 feet; thence South 00°00'00" West 997.00 feet; thence South 90(00'00" East parallel with the North line of said Northeast Quarter 317.00 feet; thence North 00(00'00" East 553.78 feet; thence South 90(00'00" West parallel with the North line of said Northeast Quarter 287.00 feet; thence North 00(00'00" East 443.22 feet to the North line of said Northeast Quarter; thence South 90°00'00" East along said section line 819.81 feet to the Northeast corner of the West Half of said Northeast Quarter; thence South 00°25'20" West along the East line of the West Half of said Northeast Quarter 2,647.92 feet to the Southeast corner of the West Half of said Northeast Quarter; thence North 89°53'07" West along the South line of said Northeast Quarter 822.07 feet to the Southeast corner of the West 30.00 Acres of said Northeast Quarter; thence North 00°08'16" East 2,646.28 feet to the point of beginning containing 45.552 Acres subject to a road right—of—way easement across the North 33.00 feet thereof and any other easements of record.
