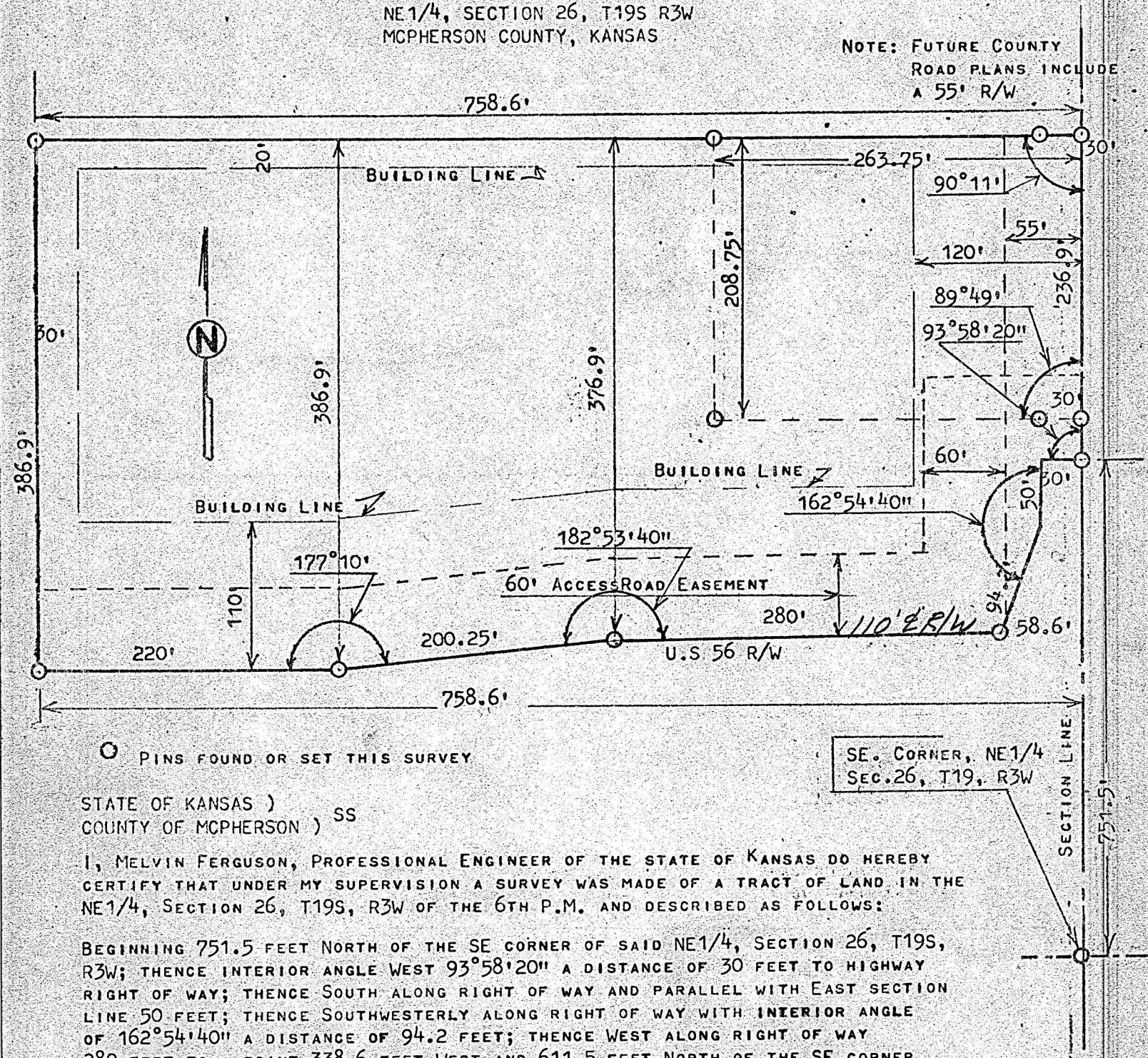


A SURVEY OF A TRACT OF LAND IN THE

CERTIFY THAT UNDER MY SUPERVISION A SURVEY WAS MADE OF A TRACT OF LAND IN THE
NE1/4, SECTION 26, T19S, R3W OF THE 6TH P.M. AND DESCRIBED AS FOLLOWS:

BEGINNING 751.5 FEET NORTH OF THE SE CORNER OF SAID NE1/4, SECTION 26, T19S,
R3W; THENCE INTERIOR ANGLE WEST 93°58'20" A DISTANCE OF 30 FEET TO HIGHWAY
RIGHT OF WAY; THENCE SOUTH ALONG RIGHT OF WAY AND PARALLEL WITH EAST SECTION
LINE 50 FEET; THENCE SOUTHWESTERLY ALONG RIGHT OF WAY WITH INTERIOR ANGLE
OF 162°54'40" A DISTANCE OF 94.2 FEET; THENCE WEST ALONG RIGHT OF WAY
280 FEET TO A POINT 338.6 FEET WEST AND 611.5 FEET NORTH OF THE SE CORNER
OF SAID NE1/4, SECTION 26; THENCE WESTERLY ALONG HIGHWAY RIGHT OF WAY
OF A INTERIOR ANGLE 182°53'40" A DISTANCE OF 200.25 FEET; THENCE WEST ALONG
RIGHT OF WAY WITH INTERIOR ANGLE OF 177°10' A DISTANCE OF 220 FEET; THENCE
NORTH PARALLEL WITH SECTION LINE 386.9 FEET; THENCE EAST 758.6 FEET TO
SECTION LINE; THENCE SOUTH ON SECTION LINE 236.9 FEET TO PLACE OF BEGINNING
SAID TRACT OF LAND CONTAINS 6.5 ACRES MORE OR LESS, AND THAT THE ABOVE PLAT
IS A TRUE EXHIBIT OF SAID SURVEY AS FAR AS IT IS KNOWN TO ME.
