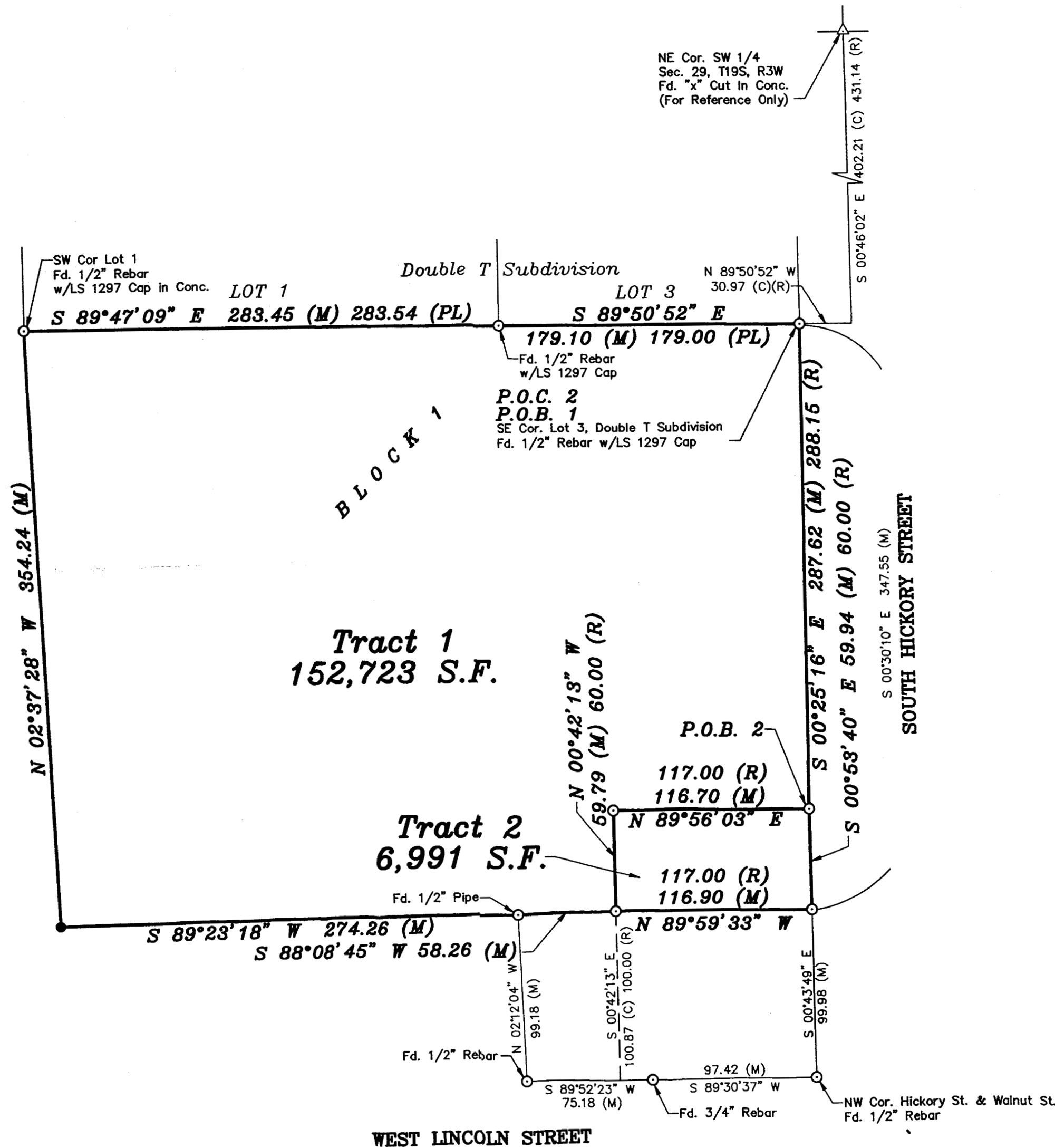

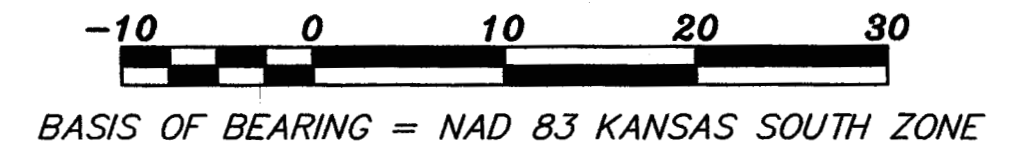


SURVEYOR'S NOTES:

DESCRIPTION:

TRACT 1

A portion of the Southwest Quarter of Section 29, Township 19 South, Range 3 West of the 6th Principal Meridian, City of McPherson, McPherson County, Kansas, described as follows by Nicholas D. Schmidt, PS #1492, this 5th day of May, 2022:

Beginning at the Southeast corner of Lot 3, Double T Subdivision in the City of McPherson, McPherson County Kansas; thence on a NAD 83 Kansas South Zone bearing of South 00°25'16" East on the West line of Hickory Street a distance of 287.62 feet; thence South 89°56'03" West a distance of 116.70 feet; thence South 00°42'13" East a distance of 59.79 feet to a point 100.87 feet (100.00 Record) North of the North line of Lincoln Street; thence South 88°08'45" West a distance of 58.26 feet; thence South 89°23'18" West a distance of 274.26 feet; thence North 02°37'28" West a distance of 354.24 feet to the Southwest corner of Lot 1 of said Double T Subdivision; thence South 89°47'09" East on the South line of said Lot 1 a distance of 283.45 feet to the Southwest corner of said Lot 3; thence South 89°50'52" East on the South line of said Lot 3 a distance of 179.10 feet to the point of beginning.

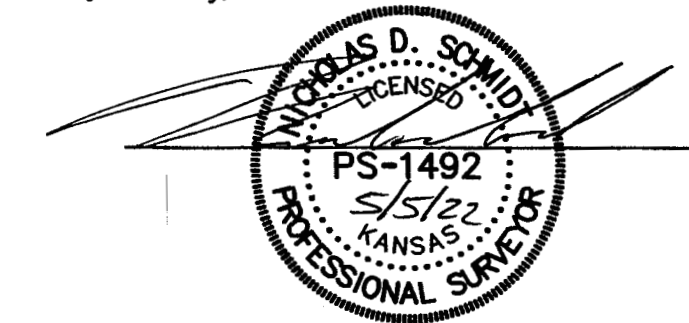

Commencing at the Southeast corner of Lot 3, Double T Subdivision in the City of McPherson, McPherson County Kansas; thence on a NAD 83 Kansas South Zone bearing of South 00°25'16" East on the West line of Hickory Street a distance of 287.62 feet to the point of beginning; thence South 00°53'40" East continuing on said West line a distance of 59.94 feet to a point 99.98 feet (100.00 Record) North of the North line of Lincoln Street; thence North 89°59'33" West a distance of 116.90 feet; thence North 00°42'13" West a distance of 59.79 feet; thence North 89°56'03" East a distance of 116.70 feet to the point of beginning.
