EXCEPT

A portion of the North Half of the Southeast Quarter of Section 29, Township 20 South, Range 2 West of the 6th Principal Meridian, McPherson County, Kansas described as

Beginning at the Southeast corner of the North Half of said Southeast Quarter; thence West along the South line of the North Half of said Southeast Quarter 775.00 feet; thence with a deflection angle 89°42'40" right-North parallel with the East line of said Southeast Quarter 282.89 feet; thence with a deflection angle 9017'00" right-East 229.62 feet; thence with a deflection angle 88°16'04" left—North 442.30 feet; thence with a deflection angle 88°48'26" right-East 529.87 feet to the East line of said Southeast Quarter; thence with a deflection angle 89°10'38" right-South along the East line of said Southeast Quarter 720.07 feet to the point of beginning, containing 10.460 Acres, subject to a road right-of-way easement across the East 33.00 feet thereof and any other easements of record.
