Commencing at the Northwest corner of said Northwest Quarter; thence on a NAD 83 Kansas South Zone bearing of North 89°38'59" East on the North line of said West Half of the Northwest Quarter a distance of 431.00 feet (Record) to the point of beginning; thence continuing North 89'38'59" East on said North line a distance of 471.00 feet; thence South 00°19'50" East parallel with the West line of said Northwest Quarter a distance of 950.37 feet; thence South 89°40'24" West a distance of 471.00 feet to a point 431.00 feet (Record) East of said West line; thence North 0019'50" West parallel with said West line a distance of 950,18 feet to the point of beginning.
