A portion of the Northwest Quarter of Section 03, Township 21 South, Range 05 West of the 6<sup>th</sup> Principal Meridian, McPherson County, Kansas more particularly described by Daniel E. Garber, PS #683, on September 8, 2022 as follows:  
Commencing at the Northwest Corner of the Northwest Quarter of Section 03, Township 21 South, Range 05 West of the 6<sup>th</sup> Principal Meridian; thence with a bearing of North 89°36'02" East (basis of bearings is NAD 83 Kansas South Zone) along the North line of said Northwest Quarter 377.65 feet for the point of beginning; thence continuing North 89°36'02" East along the North line of said Northwest Quarter 762.10 feet; thence South 00°23'58" East perpendicular to the North line of said Northwest Quarter 388.15 feet; thence South 89°36'02" West parallel with the North line of said Northwest Quarter 762.10 feet; thence North 00°23'58" West perpendicular to the North line of said Northwest Quarter 388.15 feet to the point of beginning, containing **6.791 Acres**, subject to a road right-of-way easement across the North 33.00 feet thereof and any other easements or restrictions of record.

Commencing at the Northwest Corner of the Northwest Quarter of Section 03, Township 21 South, Range 05 West of the 6<sup>th</sup> Principal Meridian; thence with a bearing of South 00°07'41" East (basis of bearings is NAD 83 Kansas South Zone) along the West line of said Northwest Quarter 1,124.94 feet to the Northwest corner of the South Half of said Northwest Quarter for the point of beginning; thence North 89°26'06" East along the North line of the South Half of said Northwest Quarter 1,771.40 feet; thence South 00°11'47" East 666.83 feet to the South line of the North Half of the South Half of said Northwest Quarter; thence South 89°31'28" West along the South line of the North Half of the South Half of said Northwest Quarter 1,772.18 feet to the Southwest corner of the North Half of the South Half of said Northwest Quarter; thence North 00°07'41" West along the West line of said Northwest Quarter 664.07 feet to the point of beginning, containing **27.067 Acres**, subject to a road right-of-way easement across the West 33.00 feet thereof, and any other easements or restrictions of record.
