Beginning at the Southeast corner of said West Half of said Section 30; thence on a NAD 83 Kansas South Zone bearing of South 89°36'55" West on the South line of said Southwest Quarter a distance of 1247.48 feet to the centerline of Lone Tree Creek; thence along said centerline for the next 5 courses:

North 1715'39" East a distance of 42.54 feet; North 44'34'37" East a distance of 126.92 feet;

North 26'36'15" East a distance of 160.05 feet;

North 04°02'10" East a distance of 47.65 feet; North 22°10'07" West a distance of 69.04 feet;

thence North 89°36'55" East parallel with said South line a distance of 1095.04 feet to the East line of said Southwest Quarter; thence South 0075'45" East on said East line a distance of 384.58 feet to the point of beginning.
