

BASIS OF BEARING = NAD 83 KANSAS SOUTH ZONE

DESCRIPTION:

A portion of the Northwest Quarter of Section 33, Township 19 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Southwest corner of said Northwest Quarter; thence on a NAD 83 Kansas South Zone bearing of North 00°30'10" West on the West line of said Northwest Quarter a distance of 39.34 feet (40 Record); thence North 89°29'50" East perpendicular to said West line a distance of 50.00 feet (Record) to the intersection with the Northerly Right of Way line of the Union Pacific Railroad (formerly Chicago Rock Island and Pacific Railroad) and the East Right of Way line of Main Street (U.S. Highway 81); thence North 00°30'10" West on said East Right of Way line a distance of 75.00 feet (Record) to the point of beginning; thence continuing North 00°30'10" West on said East Right of Way line a distance of 348.13 feet; thence North 89°20'39" East a distance of 151.97 feet; thence South 39°06'56" East a distance of 177.10 feet; thence South 13°59'31" West a distance of 85.47 feet to said Northerly Right of Way line of the Union Pacific Railroad; thence South 49°28'58" West on said Northerly Right of Way line a distance of 249.51 feet to a point 50.00 feet (Record) East of said East Right of Way line of Main Street; thence North 00°30'10" West parallel with said East Right of Way line a distance of 33.02 feet (35 Record); thence South 89°29'50" West perpendicular to said East Right of Way line a distance of 50.00 feet (Record) to the point of beginning.


