DESCRIPTION: PARCEL 1

A portion of the Southeast Quarter of Section 34, Township 21 South, Range 03 West of the 6th Principal Meridian, McPherson County, Kansas more particularly described as follows:

Beginning at the Southeast Corner of the Southeast Quarter of Section 34, Township 21 South, Range 03 West of the 6th Principal Meridian; thence with a bearing of South 89°02'21" West (basis of bearings is NAD 83 Kansas South Zone) along the South line of said Southeast Quarter 1320.00 feet; thence North 00°33'18" West parallel with the East line of said Southeast Quarter 1699.06 feet; thence North 89"19'26" East parallel with the North line of said Southeast Quarter 958.51 feet; thence South 00'33'18" East parallel with the East line of said Southeast Quarter 361.50 feet; thence North 89°19'26" East parallel with the North line of said Southeast Quarter 361.49 feet to the East line of said Southeast Quarter; thence South 00°33'18" East along the East line of said Southeast Quarter 1331.00 feet to the point of beginning, containing 48.387 Acres, subject to Road Rights—of—way across the East and South 33.00 feet thereof and any other easements or restrictions of record.

PARCEL 2


A portion of the Southeast Quarter of Section 34, Township 21 South, Range 03 West of the 6th Principal Meridian, McPherson County, Kansas


