

DESCRIPTIONS

PARCEL 1:

A tract of land in the Northeast Quarter of Section 35, Township 19 South, Range 4 West of the 6th Principal Meridian described as follows:

Commencing at the Northeast corner of the Northeast Quarter of Section 35, Township 19 South, Range 4 West of the 6th Principal Meridian; thence South along the East line of said Northeast Quarter of Section 573.44 feet for the point of beginning; thence continuing South without deflection along the East line of said Northeast Quarter 342.99 feet; thence with a deflection angle 90°06'04" right—West parallel with the North line of said Northeast Quarter 381.00 feet; thence with a deflection angle 89°53'56" right—North parallel with the East line of said Northeast Quarter 342.99 feet; thence with a deflection angle 90°06'04" right—East parallel with the North line of said Northeast Quarter 381.00 feet to the point of beginning containing 3.000 Acres in McPherson County, Kansas, subject to a road right—of—way easement across the East 33.00 feet thereof and any other easements of record.

PARCEL 2:


A tract of land in the Northeast Quarter of Section 35, Township 19 South, Range 4 West of the 6th Principal Meridian described as follows:

Commencing at the Northeast corner of the Northeast Quarter of Section 35, Township 19 South, Range 4 West of the 6th Principal Meridian; thence South along the East line of said Northeast Quarter of Section 916.43 feet for the point of beginning; thence continuing South without deflection along the East line of said Northeast Quarter 194.36 feet; thence with a deflection angle 90°06'04" right—West parallel with the North line of said Northeast Quarter 381.00 feet; thence with a deflection angle 89°53'56" right—North parallel with the East line of said Northeast Quarter 194.36 feet; thence with a deflection angle 90°06'04" right—East parallel with the North line of said Northeast Quarter 381.00 feet to the point of beginning containing 1.700 Acres in McPherson County, Kansas, subject to a road right—of—way easement across the East 33.00 feet thereof and any other easements of record.

PARCEL 3:

A tract of land in the Northeast Quarter of Section 35, Township 19 South, Range 4 West of the 6th Principal Meridian described as follows:

Commencing at the Northeast corner of the Northeast Quarter of Section 35, Township 19 South, Range 4 West of the 6th Principal Meridian; thence South along the East line of said Northeast Quarter of Section 1110.79 feet for the point of beginning; thence continuing South without deflection along the East line of said Northeast Quarter 229.22 feet; thence with a deflection angle 90°06'04" right—West parallel with the North line of said Northeast Quarter 381.00 feet; thence with a deflection angle 89°53'56" right—North parallel with the East line of said Northeast Quarter 229.22 feet; thence with a deflection angle 90°06'04" right—East parallel with the North line of said Northeast Quarter 381.00 feet to the point of beginning containing 2.001 Acres in McPherson County, Kansas, subject to a road right—of—way easement across the East 33.00 feet thereof and any other easements of record.
