SURVEYOR'S NOTE:

The deed description of record begins at the Northeast Corner of the West Half, then runs South but does not specify along the East line of the West Half. The North line of the West Half (specified in description of record) was used to align the deed description on this survey, which creates the best fit of the 19' wide portion around the driveway on the West side and appears to be the intention of the description. This creates a triangular shaped gap along the East line of the West Half being 12.84' at the Southeast corner and 0.00' at the Northeast Corner.
