



DESCRIPTIONS

A tract of land in the Northwest Quarter of Section 35, Township 21 South, Range 5 West of the 6th Principal Meridian described as follows:

Beginning at the Northwest corner of the Northwest Quarter of Section 35, Township 21 South, Range 5 West of the 6th Principal Meridian; thence East along the North line of said Northwest Quarter 2641.94 feet to the Northeast corner of said Northwest Quarter; thence with a deflection angle 90°08'38" right—South along the East line of said Northwest Quarter 663.62 feet; thence with a deflection angle 89°52'19" right—West 2642.36 feet to the West line of said Northwest Quarter; thence with a deflection angle 90°09'53" right—North along the West line of said Northwest Quarter 662.89 feet to the point of beginning containing 40.225 Acres in McPherson County, Kansas, subject to a road right—of—way easement across the West 50.00 feet thereof and any other easements of record.

Commencing at the Northwest corner of the Northwest Quarter of Section 35, Township 21 South, Range 5 West of the 6th Principal Meridian; thence South along the West line of said Northwest Quarter 662.89 feet for the point of beginning; thence with a deflection angle 90°09'53" left—East 2642.36 feet to the East line of said Northwest Quarter; thence with a deflection angle 90°07'41" right—South along the East line of said Northwest Quarter 1314.83 feet; thence with a deflection angle 90°28'53" right—West 1724.15 feet; thence with a deflection angle 46°28'22" right—Northwesterly 216.00 feet; thence with a deflection angle 43°14'28" left—West 426.50 feet; thence with a deflection angle 86°19'25" right—North parallel with the West line of said Northwest Ougster 10.00 feet; thence with a deflection angle 86°19'25" right—North parallel with the West line of said Northwest Ougster 10.00 feet; thence with a deflection angle 88°40'53" left West 346.00 said Northwest Quarter 10.00 feet; thence with a deflection angle 88*49'53" left-West 346.00 feet to the West line of said Northwest Quarter; thence with a deflection angle 88*49'53" right-North along the West line of said Northwest Quarter 1091.68 feet to the point of beginning containing 75.472 Acres in McPherson County, Kansas, subject to a road right-of-way easement across the West 50.00 feet thereof and any other easements of record.

Beginning at the Southwest corner of the Northwest Quarter of Section 35, Township 21 South, Range 5 West of the 6th Principal Meridian; thence North along the West line of said Northwest Quarter 897.00 feet; thence with a deflection angle 91"10"07" right—East 346.00 feet; thence with a deflection angle 88"49"53" right—South parallel with the West line of said Northwest Quarter 10.00 feet; thence with a deflection angle 86"19"25" left—East 426.50 feet; thence with a deflection angle 43"14"28" right—Southeasterly 216.00 feet; thence with a deflection angle 46"28"22" left—East 1724.15 feet to the East line of said Northwest Quarter; thence with a deflection angle 89"31"07" right—South along the East line of said Northwest Quarter 676.00 feet to the Southeast corner of said Northwest Quarter; thence with a deflection angle 89"55"07" right to the Southeast corner of said Northwest Quarter; thence with a deflection angle 89°55'07" right-West along the South line of said Northwest Quarter 2643.63 feet to the point of beginning containing 45.255 Acres in McPherson County, Kansas, subject to a road right—of—way easement across the West 50.00 feet thereof and any other easements of record.
