Beginning at the Southwest corner of said Southwest Quarter; thence on a NAD 83 Kansas South Zone bearing of North 00°41′42″ West on the West line of said Southwest Quarter a distance of 1419.96 feet; thence South 89°02′29″ East a distance of 2743.63 feet to the East line of said Southwest Quarter; thence South 00°32′22″ East on said East line a distance of 1391.01 feet to the Southeast corner of said Southwest Quarter; thence North 89°38′41″ West on the South line of said Southwest Quarter a distance of 2739.18 feet to the point of beginning.

Containing 88.430 Acres and subject to road right of way easements across the South and West 33.00 feet thereof, and any other easements or restrictions of record.

The West Half of the Southeast Quarter of Section 7, Township 19 South, Range 2 West of the 6th Principal Meridian, McPherson County, Kansas.


Containing **79.830 Acres** and subject to a road right of way easement across the South 33.00 feet thereof, and any other easements or restrictions of record.
