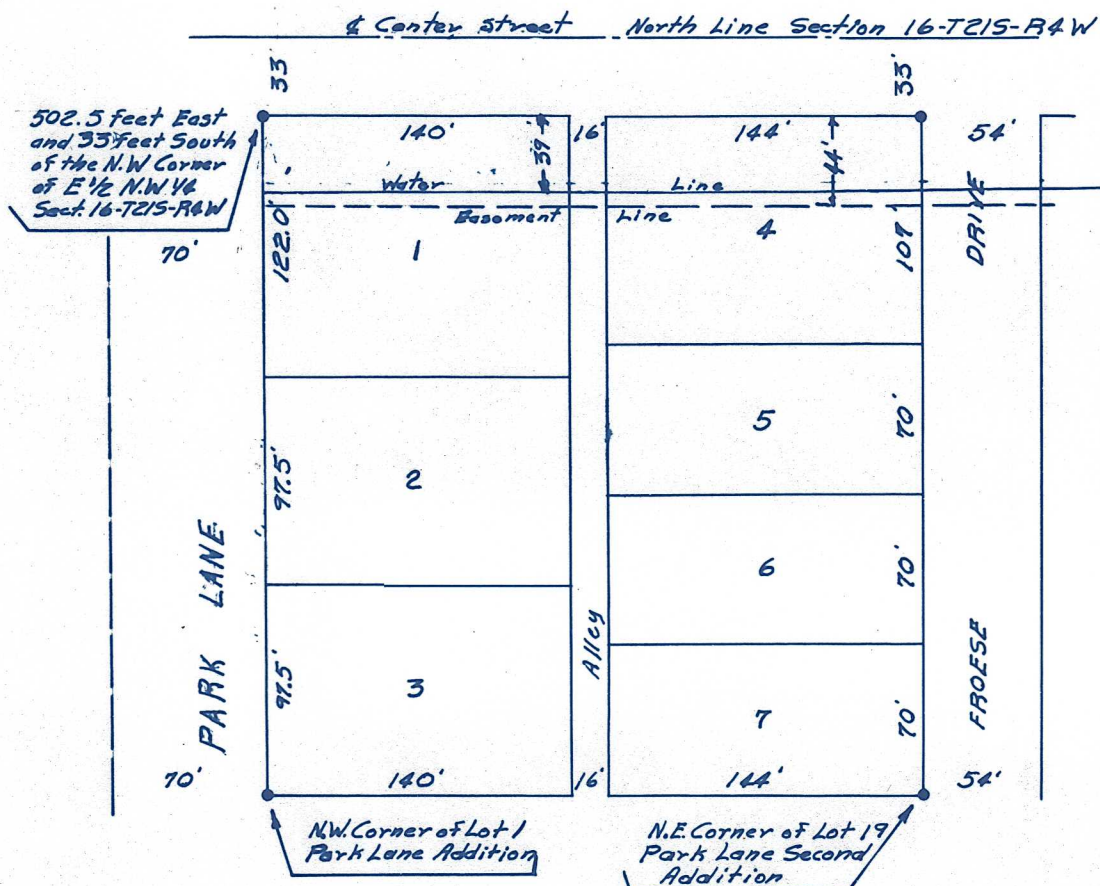


PARK LANE THIRD ADDITION INMAN, KANSAS

Beginning 33 feet South and 502.5 feet East of the N.W. Corner of said E 1/2 N.W. 1/4 Section 16, Thence East 354 feet, Thence South 317 feet, Thence West 354 feet, Thence North 317 feet to the place of beginning.
