SURVEYORS NOTES:

1. The 10' Alley along the North line of Block 1, Olson's Addition was vacated by City of Marquette Ordinance No. 534 on April 6th, 2004. Per K.S.A 14-423, "whenever any street, avenue, alley or lane shall be vacated, the same shall revert to the owners of real estate thereto adjacent on each side in proportion to the frontage of such real estate, EXCEPT in cases where such street, avenue, alley or lane shall have been take and appropriated to public use in different proportions, in which case it shall revert back to the adjacent lots of real estate in proportion as it was taken from them, and whenever any lot, block, townsite, part of townsite, addition or part of addition shall be vacated, all of the streets, avenues, alleys, and lanes therein shall revert as above provided." Since the 10' alley was dedicated as part of and taken from the Olson's Addition Plat and not part of the Hanson's 2nd Addition Plat, the exception stated in the statute applies and therefore revert back in proportion to the land from which it came from. The 143 feet of the vacated 10' alley reverts back in full to Lot 1, Block 1 of Olson's Addition.
