and being more particularly described as:

BEGINNING at the Northeast corner of Lot 1, Block 117, Original Town of McPherson, Kansas;

THENCE South along the East line of said Block 117 a distance of 301.85 feet (platted as 300 ft.) to the Southeast corner of Lot 6, said Block 117;

THENCE with a deflection angle 89*52'15" right—West along the South line of said Lot 6 a distance of 141.98 feet (platted as 142 ft.) to the Southwest corner of said Lot 6;

THENCE with a deflection angle 90°09'53" right—North 302.06 feet (platted as 300 feet) to the Northwest corner of said Lot 1;

THENCE with a deflection angle 89°55'14" right—East along the North line of said Lot 1 a distance of 141.79 feet (platted as 142 ft.) to the point of beginning, and containing 42,842.27 square feet (gross and net area).
