Roads: Smoky Valley Road is 37.5 feet wide feet on the north side of Section Line of said Section 21, T17S-R1W from road plans dated 1992, project # 59C-2834-01. Memory Trail right of way is approx. 8 feet wide, parallel with east line of this survey. This referenced 8' of right of way is owned by the Boldra Trust. An area located within the parcel surveyed above is referenced to be owned by Chester E. Anderson, c/o Retha Scott. This area is currently being used for road purposes. This area extends to the north right of way of Smoky Valley Road.

<u>Surveys:</u> G.L.O. subdivisions by Elisha Diefendorf, dated October 24-29, 1864. Survey of improvements on the west side of Roxbury by James R. Allen, dated 8-4-1980.
