

## **DESCRIPTION:**

A portion of the Southeast Quarter of Section 6, Township 17 South, Range 1 West of the 6th Principal Meridian, McPherson County, Kansas, described as follows by Nicholas D. Schmidt, PS #1492, this 10th day of June, 2024:

Commencing at the Southeast corner of said Southeast Quarter; thence on a NAD 83 Kansas South Zone bearing of North 0011'05" West on the East line of said Southeast Quarter a distance of 680.82 feet to the point of beginning; thence South 87°58'11" West a distance of 345.34 feet; thence South 3216'53" West a distance of 26.33 feet; thence South 88°04'36" West a distance of 333.54 feet; thence South 44'31'02" West a distance of 217.99 feet; thence North 79"18'05" West a distance of 471.11 feet; thence North 00"11'40" West a distance of 367.78 feet; thence North 89°31'01" East a distance of 883.29 feet; thence North 12'48'35" East a distance of 177.97 feet; thence North 88°27'09" East a distance of 66.91 feet; thence South 81°54'43" East a distance of 321.88 feet to said East line; thence South 0011'05" East on said East line a distance of 391.63 feet to the point of beginning.
