Report of Survey

Research of the records at the McPherson County Public Works Department and McPherson County Court House revealed the following information:

<u>Roads:</u> 16th Avenue is 66 feet wide, 33 feet on each side of section line. Wells Fargo Road is 66 feet wide, 33 feet on each side of section line. Public road right of way contained on the west and south sides of parcel #1 is 1.4 acre. Public road right of way contained on the south side of parcel #2 is 1.1 acre. I -135 Interstate highway, project 35W-59I-35W-1(60)100 Part III, dated 1966. Note: The public road right of way taken for I-135 highway on the east side of parcel #2 by the State Highway Commission is take in fee title and is now owned by K.D.O.T.

<u>Surveys:</u> General Land Office Subdivisions laid out by Elisha Diefendorf, completed Nov. 12, 1864. B.L.M. dependent resurvey by Allan E. Arnold, completed 10-5-1955. References found at the McPherson County Public Works vault.

<u>Field Procedure:</u> Positioning read with Ashtech Promark Static G.P.S. receivers. Distances and angles read with a Nikon DTM 522 Total Station. All distances are calculated/measured distances. I set 1/2" x 24 " rebars at the property pins monumented.
