

Beginning at the Southeast corner of said Southeast Quarter; thence on a NAD 83 Kansas South Zone bearing of South 89°37′43″ West on the South line of said Southeast Quarter a distance of 900.00 feet to the centerline of Kentucky Creek; thence on said centerline for the next 6 courses:

North 26°47'37" East a distance of 63.36 feet; North 24°16'24" East a distance of 146.29 feet; North 14°18'45" East a distance of 41.91 feet; North 26°43'43" West a distance of 79.51 feet;

North 54'14'33" West a distance of 163.15 feet; North 53'47'30" West a distance of 176.10 feet;
