5.0 acre parcel: A 5.0 acre parcel located in The West One-half (1/2) of The Southeast One Quarter (1/4) of Section Three (3), Township Seventeen (17) South – Range Three (3) West of The Sixth Principal Meridian.

Report of Survey

Research of the records at the McPherson County Public Works Department and McPherson County Court House revealed the following information:

Roads: Wildflower Lane is 66' feet wide, 33' on each side of the section line. The amount of road right of way contained in Quivira Road is 0.2 acre.

<u>Surveys:</u> Township lines ran by Divania Furrow November 1864. Original General Land Office subdivision by Elisha Diefendorf, completed November 7 thru November 12, 1864. Section corner references found at the McPherson County Public Works vault.

<u>Field Procedure:</u> G.P.S. positions were observed with Ashtech Static G.P.S. receivers. Distances and angles read with a Nikon DTM 522 Total Station. All distances are calculated/measured distances. I set 1/2" x 24 " rebars with I.D. caps at the property pins monumented.
