Report of Survey

<u>Roads:</u> Sioux Road is 66 feet wide, 33 feet on each side of section line. The 33 foot R/W area on the north side of this 10.34 acre parcel contains 0.7 acre.

<u>Surveys:</u> The Original General Land Office Township Lines run by Divania Furrow in November 1864. Original General Land Office Subdivisions completed by Elisha Diefendorf, completed November, 7 thru 12, 1864. Survey in Section 33, T17S-R3W by G.S.S., P.A., dated 10-15-1985. Survey in Section 33, T17S-R3W by W.B. Heller, dated 7-20-2006. Section corner references found at the McPherson County Public Works vault.

<u>Field Procedure:</u> G.P.S. positions were observed with Ashtech Static G.P.S. receivers. Distances and angles read with a Nikon DTM 522 Total Station. All distances are calculated/measured distances. I set 1/2" x 24 " rebars at the property pins monumented.
