DESCRIPTION OF RECORD:

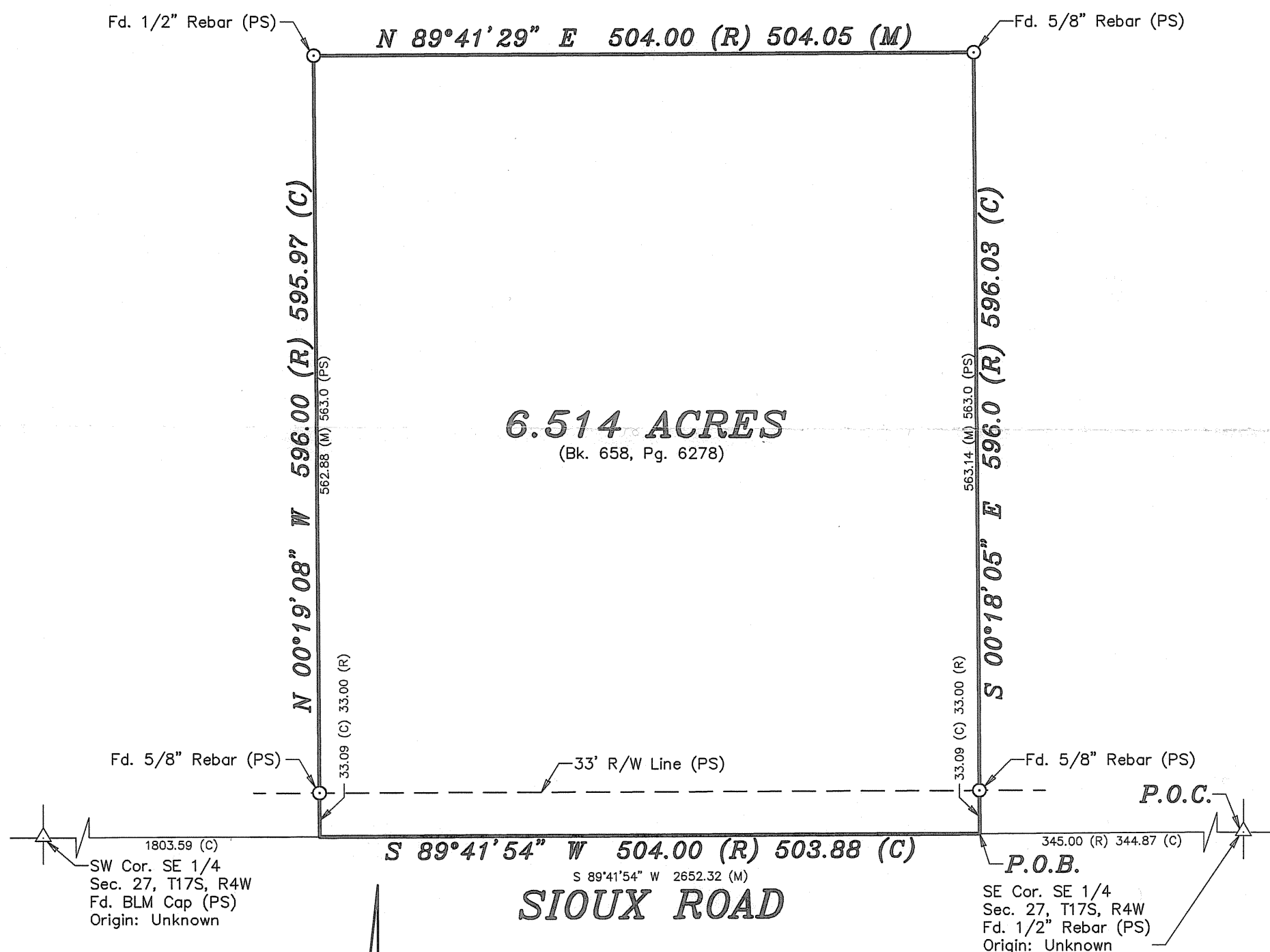
A tract of land in the Southeast Quarter, Section 27, Township 17 South, Range 4 West, described as follows:

Commencing at the Southeast corner of the Southeast Quarter, Section 27, Township 17 South, Range 4 West, of the 6th P.M., thence West on section line 345 feet for the place of beginning; thence continuing West on Section line 504 feet; thence right angle to the North 596 feet; thence East parallel with section line 504; thence South to section line 596 feet to the place of beginning. McPherson County, Kansas. Subject to public roads.

SURVEY DESCRIPTION:

A portion of the Southeast Quarter of Section 27, Township 17 South, Range 4 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Southeast corner of the Southeast Quarter of Section 27, Township 17 South, Range 4 West of the 6th Principal Meridian; thence on a Kansas State Plane Zone 1502 bearing of South 89°41'54" West along the South line of said Southeast Quarter 344.87 feet (345.0 Record) to the point of beginning; thence continuing South 89°41'54" West along said South line 503.88 feet (504.0 Record); thence North 00°19'08" West 595.97 feet (596.0 Record); thence North 89°41'29" East 504.05 feet (504.0 Record); thence South 00°18'05" East 596.03 feet (596.0 Record) to the point of beginning, containing 6.514 Acres, subject to a road right of way easement across the South 33.00 feet thereof and any other easements or restrictions of record.
