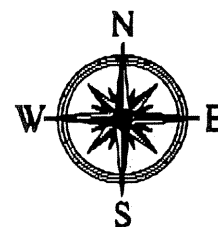
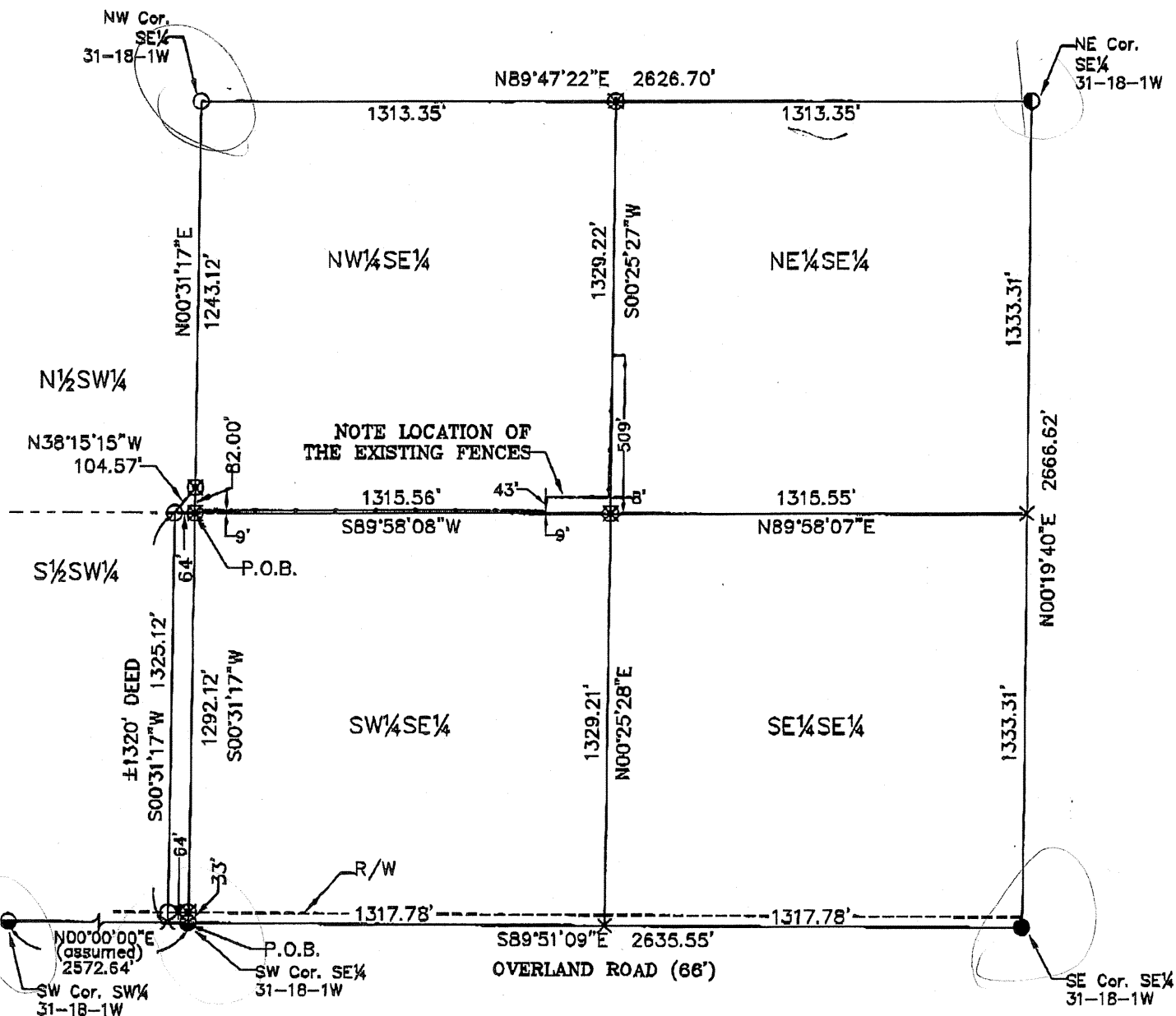

LESS THENCE NORTH 1320 FEET MORE OR LESS THENCE EAST 64 FEET MORE OR LESS,
THENCE SOUTH 1320 FEET MORE OR LESS TO THE POINT OF BEGINNING.

A TRIANGULAR TRACT OF LAND IN THE N/2 OF THE SW/4 OF SECTION THIRTY-ONE (31),

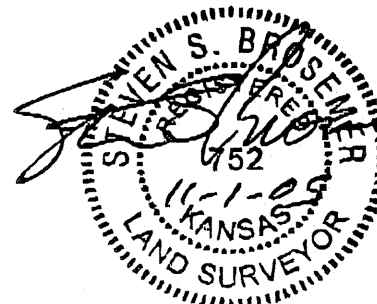
