Report of Survey

Research of the records of McPherson County Courthouse and Public Works Office revealed the following information:

<u>Surveys:</u> G.L.O. subdivisions by Diviania Furrow, dated April 8th thru April 15th, 1865. A legal survey of Section 11, T18S-R2W by County Surveyor J.D. Chamberlain, dated 1874. A legal survey of Section 11, T18S-R2W by County Surveyor Alvin Bass, dated April 24, 1885, found in Book "Surveys "A" at the McPherson County Records Vault. A 0.45 acre legal boundary survey for Arlie Holm by Melvin Ferguson, dated September 12, 1978.

Road origins: 22th Avenue is 30 feet on each side of the section line. Area contained in the right of way on the west side of this parcel #1 is 0.01 acre.

<u>Field procedure:</u> Measurements were taken of section corners and the property pins found from the 0. 45 acre survey by Melvin Ferguson with Ashtech Static G.P.S. Receivers. Stakeout of the property pins with Ashtech RTK receivers and a DTM-522 Nikon Total Station. I ran the north-south property lines of the parcels surveyed parallel with the section line between the West One Quarter (1/4) corner and The West One Sixteenth Corner of The S.W. quarter of said Section Eleven, T18S-R2W. I ran the east-west property lines parallel with the property pins set by Melvin Ferguson in 1978. Records at McPherson County Courthouse and The McPherson County Public Works Office indicate that the only surveys that were performed in this area were by The G.L.O, Alvin Bass, J.D. Chamberlain and Melvin Ferguson
