#### DESCRIPTION: PARCEL 1

A portion of the Southwest Quarter of Section 25, Township 18 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Southwest corner of said Southwest Quarter; thence on a NAD 83 Kansas South Zone bearing of North 01"01"22" West on the West line of said Southwest Quarter a distance of 314.39 feet to the point of beginning; thence continuing North 01°01'22" West on the West line of said Southwest Quarter a distance of 637.34 feet; thence South 8872'49" East a distance of 734.99 feet; thence South 01°01'22" East parallel with said West line a distance of 612.63 feet; thence South 89°51'35" West parallel with the South line of said Southwest Quarter a distance of 734.19 feet to the point of beginning.

Containing 10.533 Acres and subject to a road right of way easement across the West 33.00 feet thereof, and any other easements or restrictions of record.

### PARCEL 2

A portion of the Southwest Quarter of Section 25, Township 18 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Southwest corner of said Southwest Quarter; thence on a NAD 83 Kansas South Zone bearing of North 01°01'22" West on the West line of said Southwest Quarter a distance of 305.25 feet (Record) to the point of beginning; thence continuing North 01°01'22" West on the West line of said Southwest Quarter a distance of 9.14 feet; thence North 89'51'35" East parallel with the South line of said Southwest Quarter a distance of 734.19 feet; thence South 01'01'22" East parallel with said West line a distance of 314.39 feet to the South line of said Southwest Quarter; thence South 89°51'35" West on said South line a distance of 449.56 feet to a point 284.63 feet (Record) East of the Southwest corner of said Southwest Quarter; thence North 01'01'22" West parallel with said West line a distance of 305.24 feet (Record); thence South 89°51'35" West parallel with said South line a distance of 284.63 feet to the point of beginning.

Containing 3.304 Acres and subject to road right of way easements across the South 30.00 feet and West 33.00 feet thereof, and any other easements or restrictions of record.

## Proposed 40' Waterline Easement



Containing 3.304 Acres and subject to road right of way easements across the South 30.00 feet and West 33.00 feet thereof, and any other easements or restrictions of record.
