Report of Survey

Research of the records at the McPherson County Public Works Department and McPherson County Court House revealed the following information:

Roads: Rainbow Road is 66.0 feet wide, 33.0 feet on each side of the section line. The 30 acre parcel contains 0.5 acre of public road right of way on Rainbow Road. The 118.2 acre parcel contains 1.2 acre of public road right of way on Rainbow Road. The railroad right of way in this quarter section is conserved in a rail banking program. The abandoned Union Pacific Railroad right of way is 66.0 feet wide. Client requested that no property pins be set on the abandoned Union Pacific Railroad right of way. Railroad information found in The McPherson County Public Works Records Vault. Union Pacific Railroad Plans, Kansas Division, McPherson Branch, Salina to McPherson, drawing #35252, dated March 17, 1917.

<u>Surveys:</u> Original General Land Office subdivision by Divania Furrow, completed April 6, 1865. A 7.1 acre boundary survey by W.B. Heller, July 5, 2019. Section corner references found at the McPherson County Public Works vault.

<u>Field Procedure:</u> I used the centerline of two timber trestles on the Union Pacific Railroad for the centerline of the sixty-six-foot abandoned railroad right of way. G.P.S. positions were observed with R.T.K., Topcon GR-3 G.P.S. receivers. All distances are calculated/measured distances. I set 1/2" x 24 " rebars with I.D. caps at the property pins monumented.
