

DESCRIPTION: PARCEL 1

A portion of the West Half of the Southeast Quarter of Section 5, Township 18 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas more particularly described as follows:

Commencing at the Southwest corner of the West Half of the Southeast Quarter of Section 5, Township 18 South, Range 3 West of the 6th Principal Meridian; thence North 87°53'36" East along the South line of said West Half 547.00 feet; thence North 02°06'24" West perpendicular to said South line 93.00 feet to the point of beginning; thence continuing North 02°06'24" West perpendicular to said South line 357.00 feet; thence North 87°53'36" East parallel with said South line a 76.47 feet; thence South 01°32'48" West 69.98 feet; thence South 19°34'24" West 116.07 feet; thence South 10°28'04" West 116.27 feet; thence South 01°12'57" West 65.93 feet to the point of beginning. containing 0.29 Acre, subject to any easements or restriction of record.

PARCEL 2

A portion of the West Half of the Southeast Quarter of Section 5, Township 18 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas more particularly described as follows:

Commencing at the Southwest corner of the West Half of the Southeast Quarter of Section 5, Township 18 South, Range 3 West of the 6th Principal Meridian; thence North 87°53'36" East along the South line of said West Half 977.71 feet to the point of beginning; thence North 03°32'48" East 195.56 feet; thence North 1818'53' East 97.52 feet; thence South 02'06'24" East perpendicular to said South line 286.00 feet to said South line; thence South 87°53'36" West along said South line 53.29 feet to the point of beginning, containing 0.23 Acre, subject to a road right of way easement across the South 33.00 feet thereof, and any other easements or restriction of record.

PARCEL 3

A portion of the West Half of the Southeast Quarter of Section 5, Township 18 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas more particularly described as follows:

Commencing at the Southwest corner of the West Half of the Southeast Quarter of Section 5, Township 18 South, Range 3 West of the 6th Principal Meridian; thence North 87°53'36" East along the South line of said West Half 547.00 feet; thence North 02°06'24" West perpendicular to said South line 450.00 feet; thence North 87°53'36" East parallel with said South line 76.47 feet to the point of beginning; thence North 01"32'48" East 57.29 feet; thence North 88"11'35" East 403.88 feet; thence South 02°06'24" East perpendicular to said South line 55.06 feet; thence South 87°53'36" West parallel with said South line 407.53 feet to the point of beginning, containing 0.52 Acre, subject to any easements or restriction of record.
