Report of Survey

Research of the records at the McPherson County Public works office revealed the following information:

Roads: Road on the East side of section 21, T18S-R4W, 50' R/W, 25' on the East and West side of section line. Road width found in McPherson County Public Works section corner reference index book.

<u>Surveys:</u> G.L.O. notes and plat dated June 15-26, 1865, by Divania Furrow. References for section corners found at the records vault, McPherson County Public Works.

Field Procedure: I searched for the following monuments: E. 1/4 corner and S.E. corner of section 21, T18S-R4W. I found the East 1/4 corner and Southeast corner of section 21 in good condition. At the request of Alan James the N-S property lines of the ten acre parcel surveyed run parallel to an existing N-S fence line on the East side of the homestead. The North line of the parcel was set far enough North to include an existing sanitary sewer lagoon. Angles and distances read with a Nikon DTM 420 total station. I set 1/2"x 24" rebars with plastic I.D. caps at the property pins and section corners I monumented.
