## Legal Description:

Report of Survey

Research of the records of McPherson County revealed the following information:

Roads: Road right of way on the West side of section 18, T19S-R2W, 33.00' on each side of section line. Road right of way on the South side of section 18, T19S-R2W, 33.00' on each side of section line. Right of way on West side of parcel #1 contains 0.8 acre. Right of way on West side of parcel #2 contains 1.0 acre. Right of way on the South side of parcel #1 contains 1.3 acres.

Surveys: References for section corners found at the McPherson County Public Works vault. Boundary survey by Garber Surveying Services of the N.E. 1/4 of section 18, T19S-R2W, dated 11-8-1993, project G93-700.

Field Procedure: I searched for the following monuments: The South 1/4 Corner, the Southwest Corner, the West 1/4 Corner, and the Center corner, all in Section 18, T19S-R2W. I found these section corners in good condition. All angles and distances read with a DTM-420 total station. Pins not set on the 7.2 acre parcel in the S.W. comer of this quarter at the owners request. Pg. 1/2
