
DESCRIPTION PARCEL 1:
A portion of the Northwest Quarter of Section 23, Township 19 South, Range 2 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:
Commencing at the Southwest corner of the Northwest Quarter of Section 23, Township 19 South, Range 2 West of the 6th Principal Meridian; thence with an assumed bearing of North 00°00'00" East along the West line of said Northwest Quarter 410.00 feet for the point of beginning; thence continuing North 00°00'00" East along the West line of said Northwest Quarter 2199.70 feet to the Northwest corner of said Northwest Quarter; thence South 89°43'15" East along the North line of said Northwest Quarter 1914.57 feet (said point being 746.00 feet West of the Northeast corner of said Northwest Quarter); thence South 89°43'15" East along the North line of said Northwest Quarter 1914.57 feet (said point being 746.00 feet West of the Northeast corner of said Northwest Quarter); thence South 02°29'44" East 794.35 feet; thence South 89°43'38" East 46.08 feet; thence South 00°16'22" West 1412.01 feet; thence North 89°33'18" West 1988.55 feet to the point of beginning, containing **99.624 Acres**, subject to road right-of-way easements across the West 30.00 feet and the North 33.00 feet thereof and any other easements of record.

Beginning at the Northwest corner of the Northeast Quarter of Section 23, Township 19 South, Range 2 West of the 6th Principal Meridian; thence with an assumed bearing of South 89°08'01" East along the North line of said Northeast Quarter 1565.26 feet (said point being 1100.00 feet West of the Northeast corner of said Northeast Quarter); thence South 01°31'37" West 560.00 feet; thence South 87°25'44" West 268.00 feet; thence South 02°57'04" West 734.31 feet to the South line of the North Half of said Northeast Quarter; thence North 89°15'28" West along the South line of the North Half of said Northeast Quarter 1246.55 feet to the Southwest corner of the North Half of said Northeast Quarter; thence North 00°04'47" East along the West line of the North Half of said Northeast Quarter 1312.69 feet to the point of beginning, containing **41.902 Acres**, subject to a road right-of-way easement across the North 33.00 feet thereof and any other easements of record.

Commencing at the Northwest corner of the Northeast Quarter of Section 23, Township 19 South, Range 2 West of the 6th Principal Meridian; thence with an assumed bearing of South 89°08'01" East along the North line of said Northeast Quarter 1565.26 feet for the point of beginning; thence continuing South 89°08'01" East along the North line of said Northeast Quarter 1100.00 feet to the Northeast corner of said Northeast Quarter; thence South 00°17'17" West along the East line of said Northeast Quarter 1306.86 feet to the Southeast corner of the North Half of said Northeast Quarter; thence North 89°15'28" West along the South line of the North Half of said Northeast Quarter 1413.88 feet; thence North 02°57'04" East 734.31 feet; thence North 87°25'44" East 268.00 feet; thence North 01°31'37" East 560.00 feet to the point of beginning, containing **38.160 Acres**, subject to road right-of-way easements across the North and East 33.00 feet thereof and any other easements of record.
