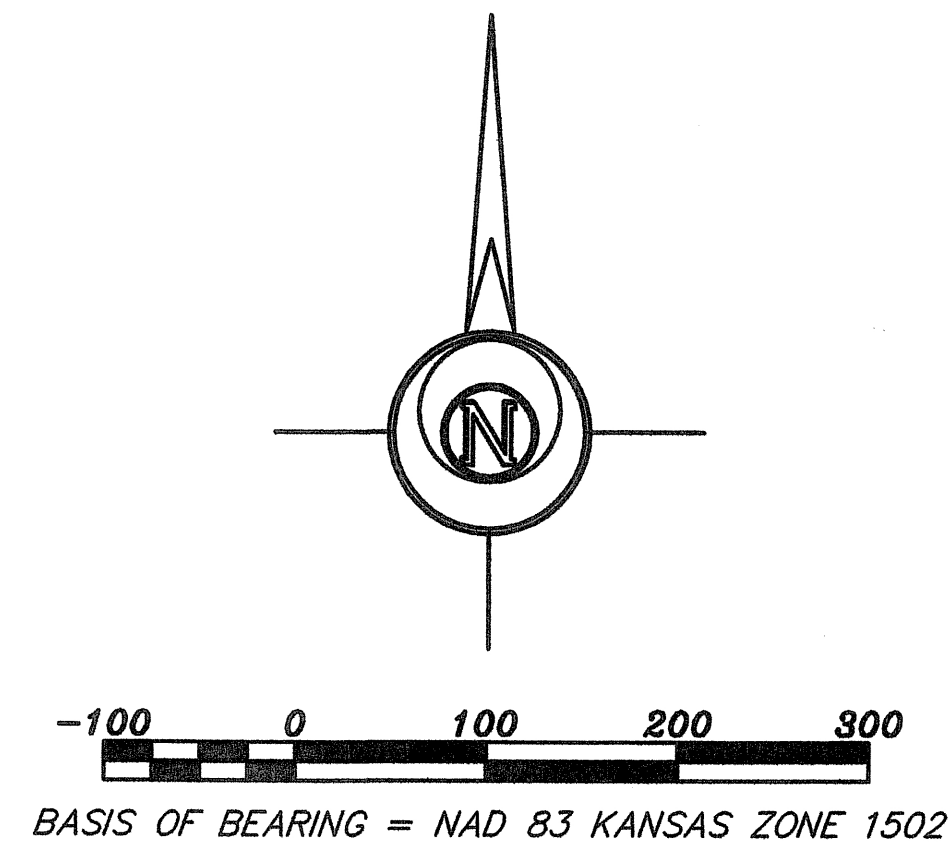
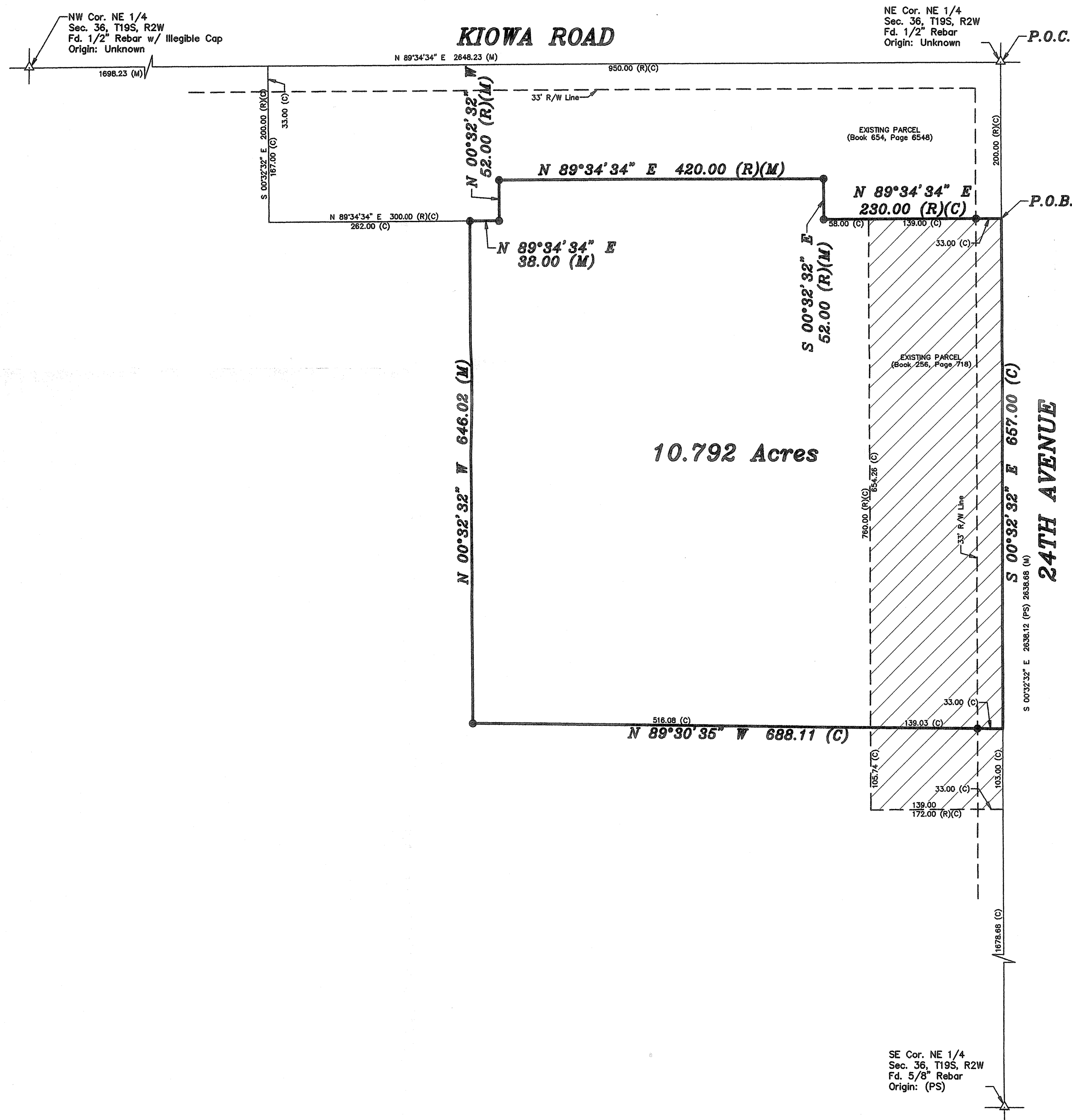

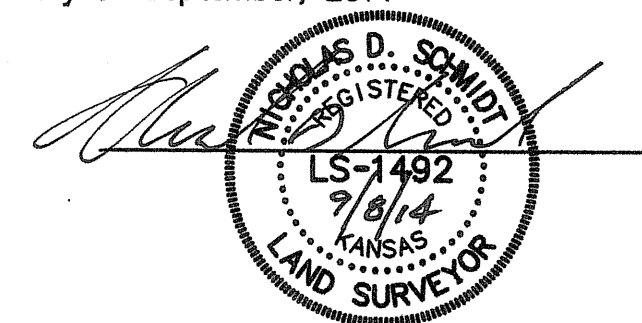
DESCRIPTION:

A portion of the North Half of the Northeast Quarter of Section 36, Township 19 South, Range 2 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Northeast corner of the Northeast Quarter of Section 36, Township 19 South, Range 2 West of the 6th Principal Meridian; thence on a NAD 83 Kansas Zone 1502 bearing of South 00°32'32" East along the East line of said Northeast Quarter 200.00 feet (Record) to the POINT OF BEGINNING; thence continuing South 00°32'32" East along said East line 657.00 feet; thence North 89°30'35" West 688.11 feet; thence North 00°32'32" West parallel with said East line 646.02 feet to a point 167.00 feet (Record) south of the North line of said Northeast Quarter; thence North 89°34'34" East parallel with said North line 38.00 feet; thence North 00°32'32" West parallel with said East line 52.00 feet (Record); thence North 89°34'34" East parallel with said North line 420.00 feet (Record); thence South 00°32'32" East parallel with said East line 52.00 feet (Record); thence North 89°34'34" East parallel with said North line 230.00 feet (Record) to the POINT OF BEGINNING, containing **10.792 Acres**, subject to a road right of way easement across the East 33.00 feet thereof and any other easements or restrictions of record.
