



## SURVEYOR'S NOTES:

- 1) The Right of Way for Meadowlark Street was originally conveyed for U.S. Highway 50 by way of a Quit Claim Deed to the Board of County Commissioners and their successors on May 8th, 1928 (Book 96, Page 300). That conveyance was a tract of land 60' wide. The Board of County Commissioners conveyed, by way of a Quit Claim Deed (Book 196, Page 627), a tract of land 10' wide along the Northwesterly side of the 60' R/W back to the adjacent land owner to the North on March 29th, 1978. This resulted in a 50' R/W for U.S. Highway 50, now re-named Meadowlark Street. No additional vacations or conveyances were recorded.
- 2) No public Right of Way has been dedicated for Prairie Road as per records at the McPherson County Register of Deeds Office, therefore, Prairie Road is a private drive owned by Mustang Park, LLC.
- 3) The record deed and R/W information listed on this survey is from recorded documents for Block 1 and 2, College Place Addition, on file at the McPherson County Register of Deeds Office.
- 4) Previous surveys shown are on file at the McPherson County Public Works Office. The Southeasterly R/W line for former U.S. Highway 50 shown on (PS2) and (PS3) differs from the location shown on this survey. There are no documents recorded at the McPherson County Register of Deeds Office to substantiate the location of the R/W as shown on said previous surveys.
