## NEW PARCEL DESCRIPTION:

A portion of the Southeast Quarter of Section 9, Township 19 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas, described as follows:

Commencing at the Southwest corner of said Southeast Quarter; thence on a NAD 83 Kansas South Zone bearing of North 88°36'40" East on the South line of said Southeast Quarter a distance of 140.00 feet (Record) to the Southeast corner of a parcel described in Book 645, Page 5417 at the McPherson County Register of Deeds Office; thence North 00°10'02" on the East line of said parcel a distance of 479.88 feet (480 Record); thence North 88°36'40" East on said East line a distance of 20.00 feet (Record); thence North 00°10'02" West on said East line a distance of 70.00 feet (Record); thence South 88°36'40" West on said East line a distance of 20.00 feet (Record); thence North 00°10'02" West on said East line a distance of 90.00 feet (Record) to the Northeast corner of said parcel; thence North 88°36'40" East parallel with said South line a distance of 218.98 feet; thence South 00°10'02" East parallel with the West line of said Southeast Quarter a distance of 639.88 feet to said South line; thence South 88°36'40" West on said South line a distance of 218.98 feet to the point of beginning.

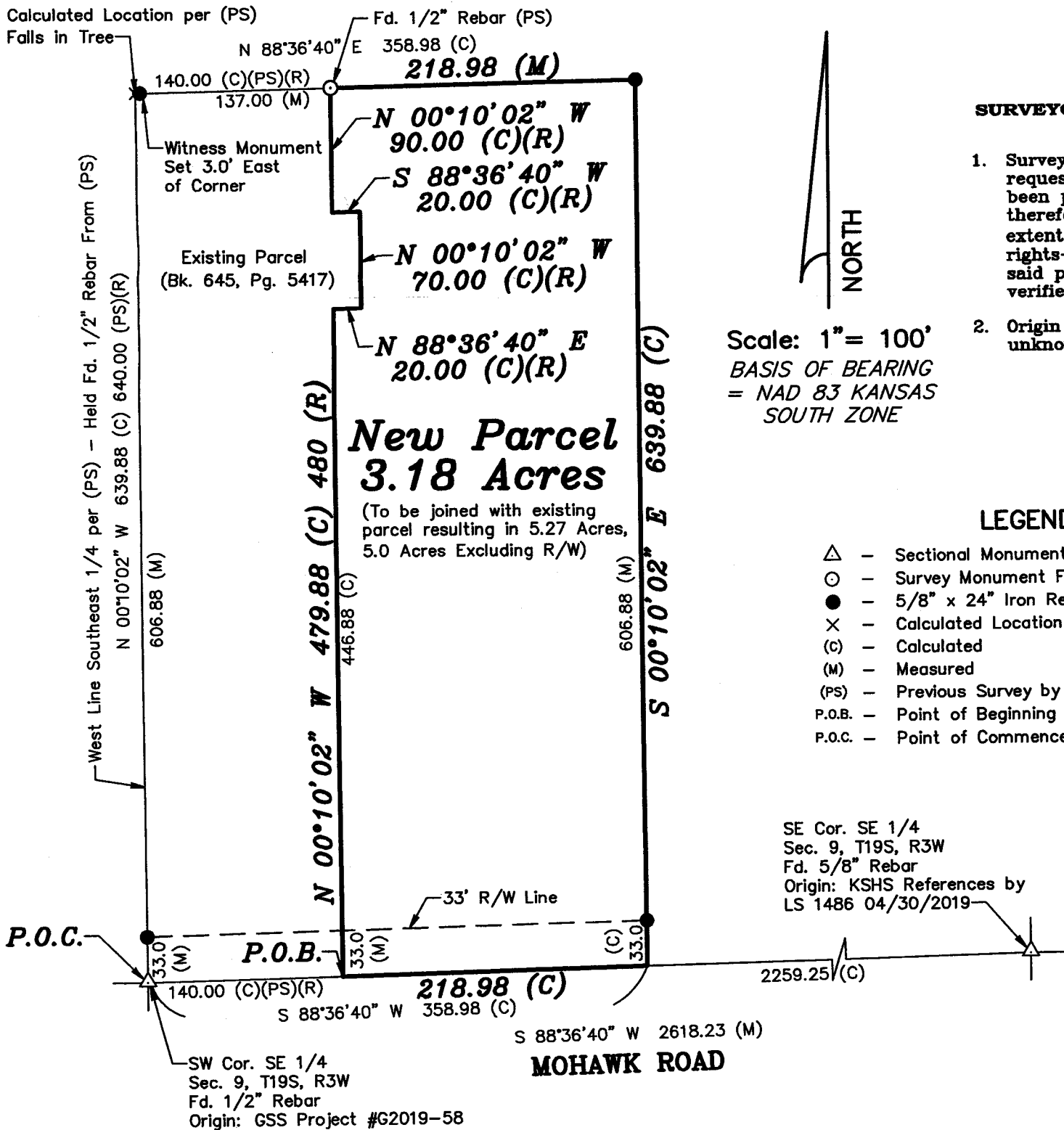

Containing 5.27 Acres and subject to a road right of way easement along the South line thereof, and any other easements or restrictions of record.
