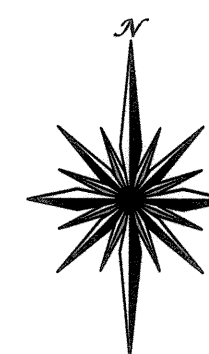

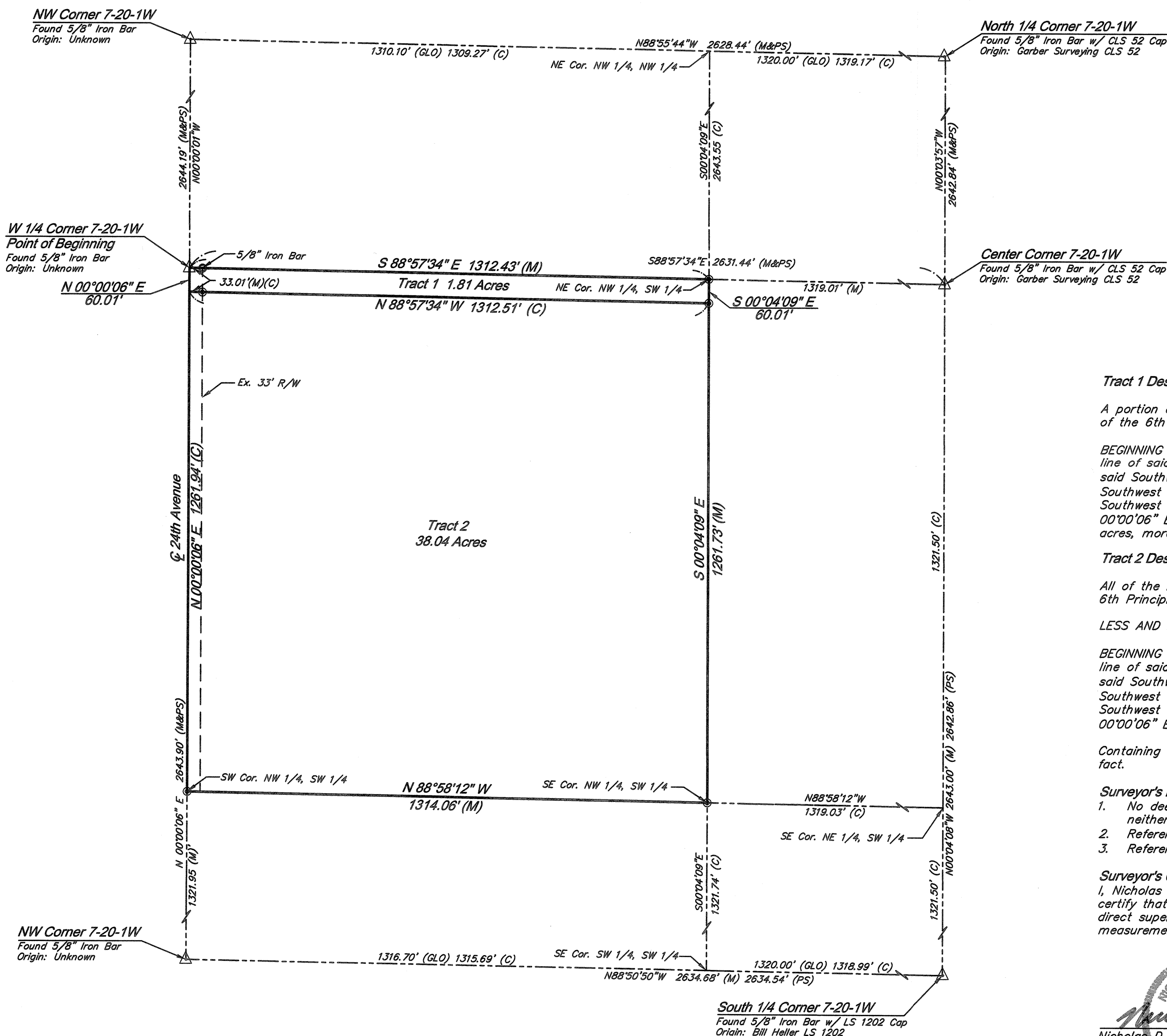
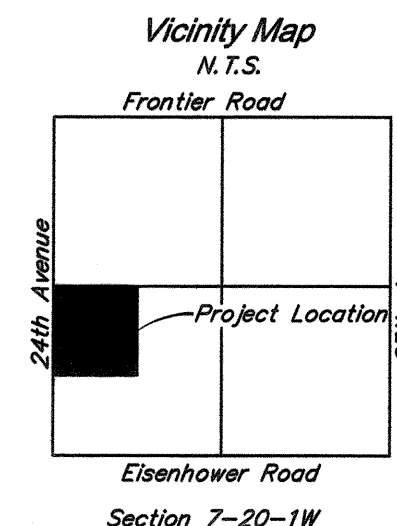

Tract 1 Description (Recommended): 1.81 Acres

A portion of the Northwest Quarter of the Southwest Quarter of Section 7, Township 19 South, Range 1 West of the 6th Principle Meridian, McPherson County, Kansas, being more particularly described as follows:

BEGINNING at the Northwest corner of said Southwest Quarter; thence South 88°57'34" East, along the North line of said Southwest Quarter, a distance of 1312.43 feet to the Northeast corner of the Northwest Quarter of said Southwest Quarter; thence South 00°04'09" East, along the East line of the Northwest Quarter of said Southwest Quarter, a distance of 60.01 feet; thence North 88°57'34" West, parallel to the North line of said Southwest Quarter, a distance of 1312.51 feet to the West line of said Southwest Quarter; thence North 00°00'06" East, along said West line, a distance of 60.01 feet to the POINT OF BEGINNING and containing 1.81 acres, more or less and subject to any rights of way, restrictions, or easement of record or fact.

Tract 2 Description (Recommended): 38.04 Acres

All of the Northwest Quarter of the Southwest Quarter of Section 7, Township 19 South, Range 1 West of the 6th Principle Meridian, McPherson County, Kansas;

LESS AND EXCEPT

BEGINNING at the Northwest corner of said Southwest Quarter; thence South 88°57'34" East, along the North line of said Southwest Quarter, a distance of 1312.43 feet to the Northeast corner of the Northwest Quarter of said Southwest Quarter; thence South 00°04'09" East, along the East line of the Northwest Quarter of said Southwest Quarter, a distance of 60.01 feet; thence North 88°57'34" West, parallel to the North line of said Southwest Quarter, a distance of 1312.51 feet to the West line of said Southwest Quarter; thence North 00°00'06" East, along said West line, a distance of 60.01 feet to the POINT OF BEGINNING.

Containing 38.04 acres, more or less and subject to any rights of way, restrictions, or easements of record or fact.
