


BASIS OF BEARING = KANSAS STATE PLANE ZONE 1502

DESCRIPTION:

PARCEL 1

900

A portion of the Northwest Quarter of Section 13, Township 20 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Beginning at the Northwest corner of the Northwest Quarter of Section 13, Township 20 South, Range 3 West of the 6th Principal Meridian; thence on a Kansas State Plane Zone 1502 Bearing of North 88°39'31" East along the North line of said Northwest Quarter 2622.64 feet to the Northwest corner of a parcel of land described in Deed Book 174, Page 45 recorded at the McPherson County Register of Deeds Office, said corner being 114.18 feet (Record) West of the Northeast corner of said Northwest Quarter; thence South 01°24′59" East along the West line of said parcel 845.73 feet; thence South 88°39′31" West parallel with the North line of said Northwest Quarter 2631.00 feet to the West line of said Northwest Quarter; thence North 00°50′59" West along the West line of said Northwest Quarter 845.76 feet to the point of beginning, containing 51.000 Acres, subject to road right of way easements across the West and North 33.00 feet thereof and any other easements or restrictions of record.

PARCEL 2

A portion of the Northwest Quarter of Section 13, Township 20 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Northwest corner of the Northwest Quarter of Section 13, Township 20 South, Range 3 West of the 6th Principal Meridian; thence on a Kansas State Plane Zone 1502 Bearing of South 00°50′59" East along the West line of said Northwest Quarter 845.76 feet to the point of beginning; thence North 88°39'31" East parallel with the North line of said Northwest Quarter 2631.00 feet to the West line of a parcel of land described in Deed Book 174, Page 45 recorded at the McPherson County Register of Deeds Office; thence South 01°24'59" East along the West line of said parcel 471.05 feet to the Southwest corner of said parcel, said corner being on the South line of the North Half of said Northwest Quarter; thence North 88°41'22" East along the South line of said parcel, also being the South line of said North Half, 85.14 feet (Record) to the Southeast corner of said North Half; thence South 00°09'11"East along the East line of said Northwest Quarter 1317.11 feet to the Southeast corner of said Northwest Quarter; thence South 88°43'15' West along the South line of said Northwest Quarter 2524.76 feet to a point 180.00 feet (Record) East of the Southwest corner of said Northwest Quarter; thence North 17°59'45" West 472.66 feet (472.60 Record); thence South 89°09'01" West perpendicular to the West line of said Northwest Quarter 40.65 feet to the West line of said Northwest Quarter; thence North 00°50'59" West along the West line of said Northwest Quarter 1322.05 feet to the point of beginning containing 109.250 Acres, subject to a road right of way easement across the West 33.00 feet thereof and any other easements or restrictions of record.
