
A portion of the Southwest Quarter of the Southwest Quarter of Section 23, Township 20 South, Range 3 West of the 6th Principal Meridian, McPherson County, Kansas described

Beginning at the Northeast corner of the Southwest Quarter of said Southwest Quarter; thence on a NAD 83 Kansas South Zone bearing of thence South 00°01'12" East on the East line of said Southwest Quarter of the Southwest Quarter a distance of 601.55 feet to the North line of vacated Third Street, Elyria, McPherson County, Kansas; thence North 88°40'26" West on said North line a distance of 50.00 feet to the West line of Main Street of said Elyria; thence South 00°01'12" East on said West line a distance of 30.01 feet to the Elyria; thence South 00°01'12" East on said West line a distance of 30.01 feet to the centerline of said vacated Third Street; thence North 88'40'26" West on said centerline a distance of 243.73 feet to the Easterly Right of Way line of the Kansas and Oklahoma Railroad; thence North 42'37'41" West on Right of Way a distance of 618.19 feet; thence continuing on said Right of way following the arc of a curve to the right having a radius of 27999.59 feet a distance of 254.59 feet (chord bears North 40'52'03" West a distance of 254.59 feet) to the North line of said Southwest Quarter of the Southwest Quarter; thence South 88'31'34" East on said North line a distance of 878.96 feet to the point of beginning.
