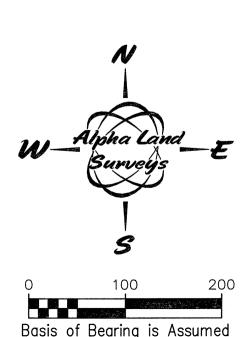

#### **GENERAL NOTES:**

- 1) Section corner reference ties filed with the Kansas State Historical Society and the McPherson County Public Works Department as required by KSA 1987 Supp. 58—2001.
- 2) No titlework was provided by client for subject property. Easements and rights—of—ways affecting subject property are not shown.
- 3) To re—establish the Northeast corner of said Northwest Quarter, research of records at the McPherson County Public Works Department yielded only ties of hedge rows running North and South. A survey dated March 1877 on file in Record of Permanent Surveys Book "B", page 4 records the Northeast corner of the Northwest Quarter was set on line and midway between section corners but that the corner also fit tree lines which also matched the reference ties. The mid point between section corners fell 75 feet East of the ancient tree lines and 5.4 feet South of the centerline of the paved road. I accepted the centerline of the paved roadway and the intersection of the tree row for the corner position which fits the survey referenced above within 0.4 foot.
- 4) The road right—of—way is shown as based upon FAS plans 374—1 and 374—3 on file in the McPherson County Public Works Department.
