

DESCRIPTION:

A portion of the Northwest Quarter of Section 7, Township 20 South, Range 4 West of the 6th Principal Meridian, McPherson County, Kansas, described as follows by Nicholas D. Schmidt, PS #1492, this 18th day of July, 2023:

Commencing at the Southwest corner of said Northwest Quarter; thence on a NAD 83 Kansas South Zone bearing of North 00°18'31" East on the West line of said Northwest Quarter a distance of 359.06 feet to the Northwest corner of a parcel described in Book 668, Page 21285 at the McPherson County Register of Deeds Office, being the point of beginning; thence continuing thence North 00°18'31" East on said West line a distance of 919.23 feet; thence South 40'36'11" East a distance of 954.19 feet to the North line of said parcel; thence South 8075'55" West on said North line a distance of 196.50 feet; thence South 02°56'32" East on said North line a distance of 141.60 feet; thence South 88°20'00" West on said North line a distance of 198.52 feet; thence South 00°05'54" West on said North line a distance of 9.67 feet; thence South 88'53'21" West on said North line a distance of 241.14 feet to the point of beginning.

Containing 7.12 Acres and subject to a road right of way easement along the West line thereof, and any other easements or restrictions of record.
